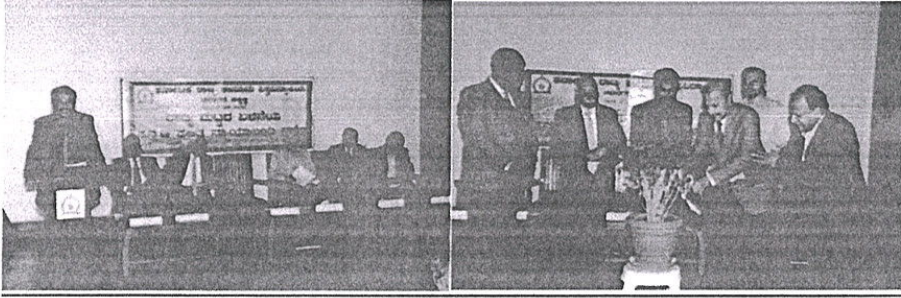
State Level Kannada Moot Court Competition

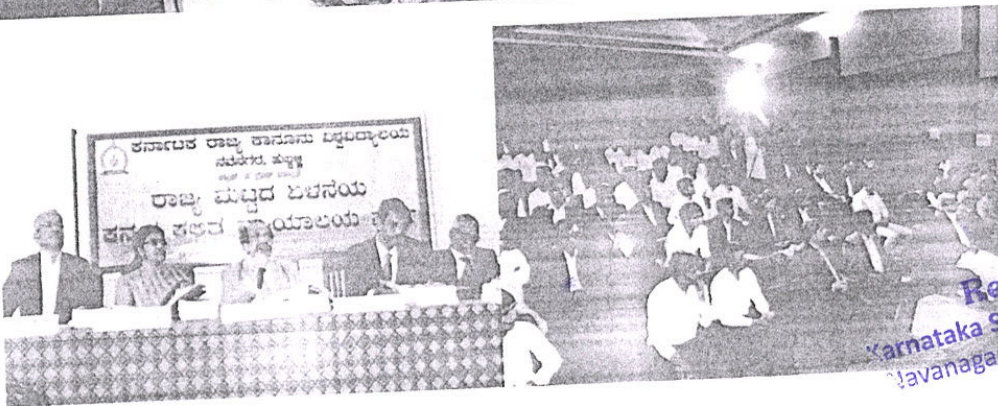

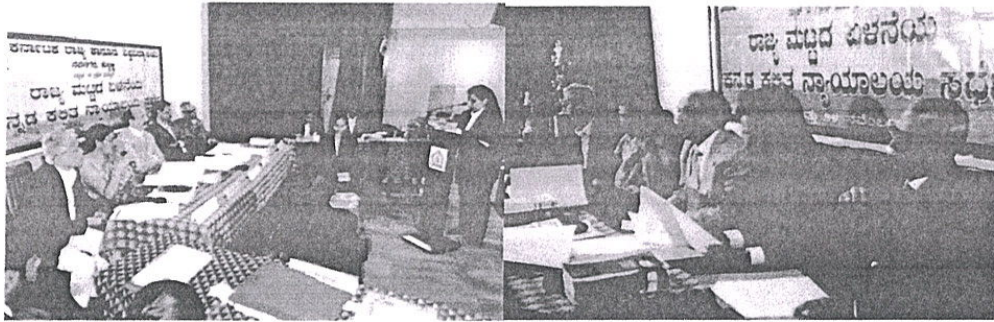
