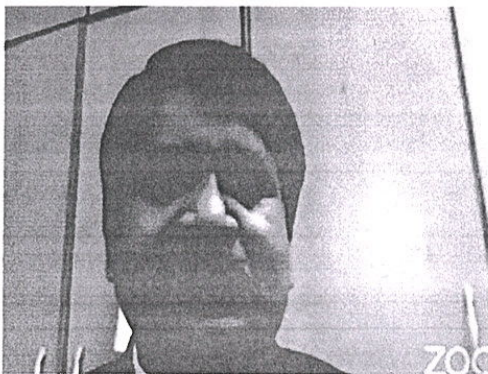

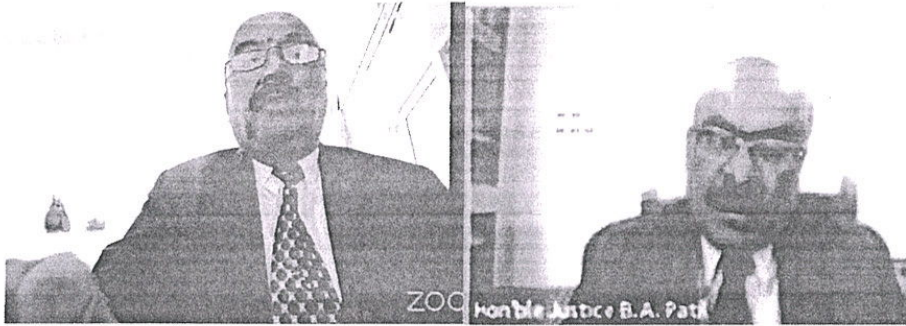

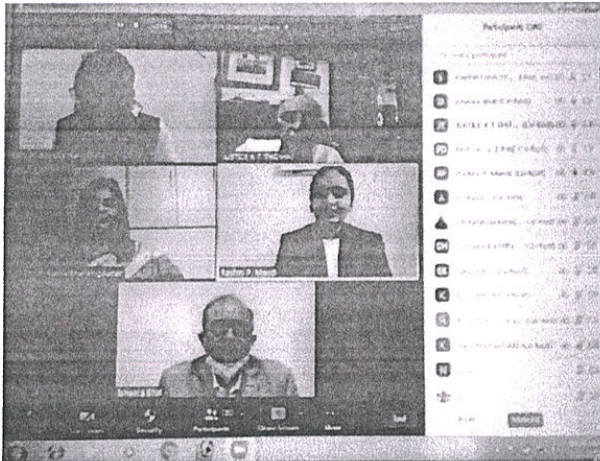

Inaugural Function of 7 International Law Moot Court Competition – 2021

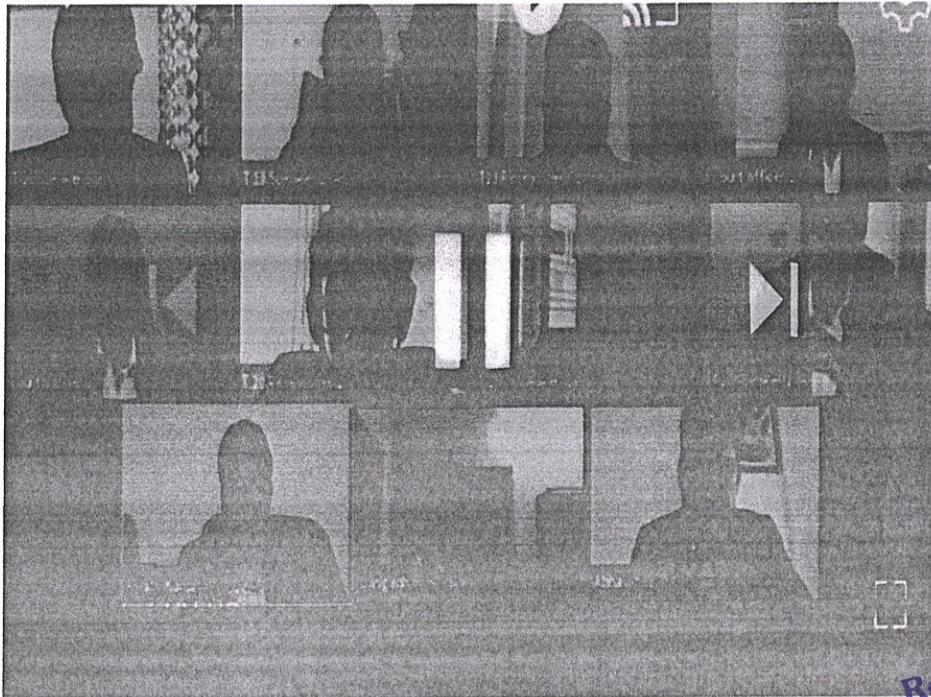
