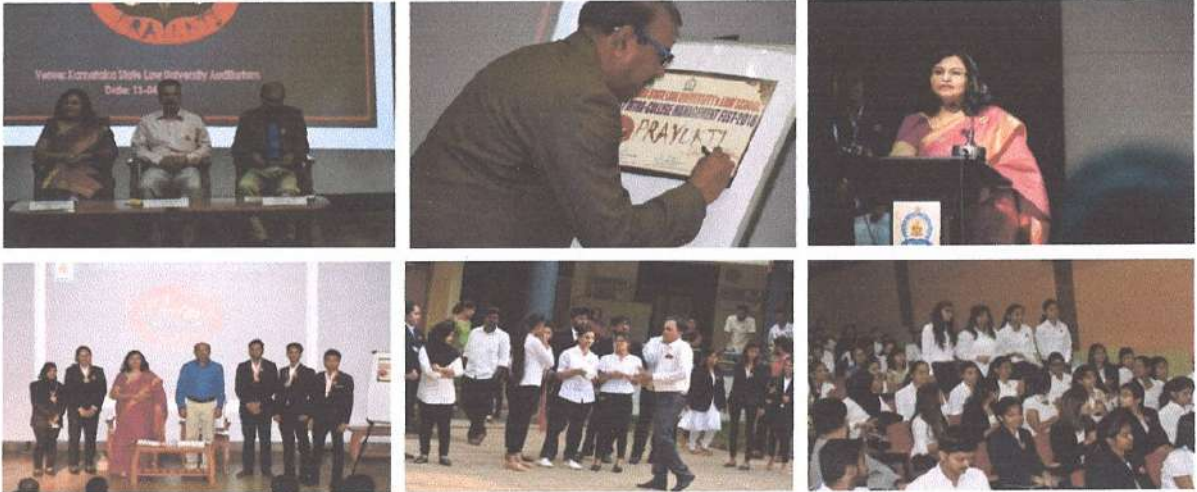
MANAGEMENT FEST-2018 'PRAYUKTI'
