2. INTER UNIVERSITY:

A. It was resolved to send the following teams to Inter University Tournaments for the year 2017-18 provided the dates of the events and semester exams do not clash.

- B. It was resolved to provide TA, DA, Honorarium and other allowances for University Blues and KSLU's Law School Students. Coaches, Managers, Physical Education Directors, Selection Committee Members, Convener, Sports Advisory Committee Members, Director Physical Education etc., the existing TA, DA, Honorarium and other allowances.
- C. It was resolved to provide the University Blues the existing Match DA per Student @ Rs. 100 per match for Team Events and @ Rs. 200 for Individual events per heats.
- D. It was resolved to provide the University Blues T-shirts, Shorts, Shoes, socks and Track Suit.
- **E.** It was resolved not to issue Blazers for University Blues and Physical Education Directors from 2013 onwards.
- F. It was resolved to appoint 2 selection committee members from KSLU, one from outside, Director Physical Education of KSLU as Chairman of selection committee and Principal of the host college as the convener to constitute KSLU team to participate in Inter University Tournaments.
- G. It was resolved to appoint one Coach and one Manager for coaching camp and both to escort KSLU Team in Inter University Tournaments.
- **H.** It was resolved that a maximum of 6 students are permitted to attend the University Blue selection trials from each college.
- I. It was resolved not to provide cash award to the University Blues participating for the Second Time a Cash Award of Rs. 2000/-, Third Time Rs. 3000/-, Fourth Time Rs. 4000/and Fifth Time Rs. 5000/-respectively as the University has not issued any such cash award to any one till date.

Dundu

- J. It was resolved not to levy any entry fees for University Blue Selections.
- K. It was resolved that Physical Education Director of the host college will be the manager for the University team.
- L. It was resolved to provide Badminton Cock, balls, etc., by KSLU for hosting Inter University Selection trials to the host colleges.
- M. It was resolved that the University Blue Cricket Selections will be held at KSLU, Hubballi.
- N. It was resolved to continue to provide the Students securing 01st to 08th Place in All India Inter University Competition in individual events an award of Rs. 1,00,000/- for each Student. The cash prize will not be repeated for the same person.
- O. It was resolved to continue to provide the teams securing 1st to 4th place, in South Zone Inter University Tournament in Team events an awarded of Rs. 2,00,000/- to be distributed equally among Students, Coach & Manager.
- P. It was resolved that in case some extraordinary students want to participate in the individual events and team events which are not covered in the Para No. 2 (A), a committee of two Sports Advisory Committee Members, one event specialized expert and Director Physical Education along with the higher authorities will take a decision to send the team.
- Q. It was resolved to continue to provide the host college with existing Rs.10,000/-for hosting University Blue Selections.

3. POINT SYSTEM:

It was resolved to continue the existing Point System Rules of the previous year.

- a) First, Second and Third place cash prize winners from 2017-18 onwards will not get any cash award for next three years i.e. First to Sixth place, but ranking will be awarded.
- b) Slab points for standard and quality of sports have been increased from 850, 750 and 650 to 1000, 900 & 800 points for First, Second & Third places respectively.
- c) No slab for Fourth to Sixth place.
- d) 20 negative points for the absence of Managers.
- e) 50 negative points for an indiscipline team.
- f) 3 years ban for inclusion of other than registered college students.
- g) Each team participating in Intercollegiate Meet, Men and Women events will be awarded 25 points each.
- h) Winning Team in Intercollegiate will get 20 points.
- i) Runners up in Intercollegiate will get 15 points.
- j) Third place in Intercollegiate will get 10 points.
- k) Fourth place in Intercollegiate will get 5 points.
- 1) Physical Education Director/Manager escorting the team will be awarded 20 points
- m) University Blue per student will get 25 points each.
- n) Hosting the Intercollegiate Meet 25 points for men and 25 points for women.

- o) Hosting the Selection trails will get 25 points.
- p) Attending the University selection Trails will get 10 points per student.
- q) KSLU's Law School, Navanagar, Hubballi is exempted from the cash award.
- r) Trophies & certificates will be issued for First to Sixth Ranks.
- s) To distribute Sports Equipments to the winners/Ranked Colleges in Point system for the academic year from 2015-16 to 2017-18 by inviting E-Tender existing amount as shown below.

4. INTERCOLLEGIATE:

- a. It was resolved to continue to provide the athletes who create new records in Athletic meet a cash award of Rs 5000/-. In case many athletes break the record, only the person securing First place will be rewarded.
- **b.** It was resolved to continue to provide the Best Male and Female Athlete in Athletic Meet with a cash award of Rs 10,000/- each. In case of tie, the same amount shall be shared.
- c. It was resolved not to levy any entry fees for Intercollegiate Tournaments.
- d. It was resolved that host college will provide Food & Accommodation to all the participants and managers. The University shall bear these expenses as per norms.
- e. It was resolved that Medals, Trophy's and Certificates will be provided by KSLU for Intercollegiate competition.
- f. It was resolved that each college must participate in at least 5 Intercollegiate Tournaments.
- g. It was resolved to provide existing per day boarding and lodging charges per student / manager per day Rs. 250 to be paid to the host colleges who conduct Intercollegiate Tournaments.
- **h.** It was resolved to provide existing amount of expenditure Rs. 15,000/- to colleges which organize Intercollegiate Competitions and Rs. 50,000/- to college which conduct Intercollegiate Cricket Tournaments.
- i. It was resolved to give advance amount of Rs. 25,000/- to colleges which organize intercollegiate competitions and Rs. 50,000/- for college which conduct Intercollegiate Cricket tournament.
- j. It was resolved that the Host College should arrange a clinic in their respective Game at the existing honorarium of Rs. 1,000/- to be borne
- k. It was resolved that Intercollegiate Athletic Meet will be held in Single Zone at KSLU.

- l.lt was resolved to provide T-shirt, Shots, Caps, TA, Accommodation, Local Transportation, Good Nutrition food such as Milk, Egg, Fruits and quality Dinner during the Intercollegiate Athletic Meet.

- b. It was resolved to reserve one seat for sports quota in Admission for Law Courses. Proposal will be submitted to KSLU for considering one percentage.
- c. It was resolved to provide a Gold Medal or scholarship for the best outgoing Sportsperson at Intercollegiate Athletic Mect every year.
- d. It was resolved to obtain consent of Parents and Principals of students for participants in competition.
- e. It was resolved to provide Insurance for the University Blues participating in competitions, by their respective college principals.

- m. It was resolved to purchase of Trophies and Medals and Certificate for Intercollegiate
 Tournaments.
- n. It was resolved to Purchase Equipments required for Inter Collegiate Athletic Meet.
- o. Purchase of equipments worth Rs. 2,85,000/- for winners of Points System every year.
