- A brief report of Sports Activities for the year of 2015-16 was presented by Mr.
  Khalid Khan Director, Physical Education through the Power Point presentation
  which included Inter University and Inter- Collegiate Tournaments.



## The following items were discussed and resolved as under:

1. Confirmation of Proceedings of the Previous Meeting i.e., 7<sup>th</sup> Physical Education Director and 5<sup>th</sup> Sports Advisory Committee Meeting held on 19<sup>th</sup> August 2015.

#### 2. INTER UNIVERSTITY:

a. It was resolved to send the following teams for Inter University Tournaments for the year 2016-17 provided the dates of the events and semester exams do not clash.

- b. It was resolved to provide TA, DA, Honorarium and other allowances for University Blues and KSLU's Law School Students. Coaches, Managers, Physical Education Directors, Selection Committee Members, Convener, Sports Advisory Committee Members, Director Physical Education etc., the existing TA, DA, Honorarium and other allowances.
- c. It was resolved to provide University Blues the existing Match DA per Student @ Rs. 100 per match for Team Events and @ Rs. 200 for Individual events per heats.
- d. It was resolved to provide University Blues T-shirts, Shorts, Shoes, socks and Track Suit.
- e. It was resolved to provide Blazer for University Blues and Physical Education Director only once.
- f. It was resolved to appoint 2 selection committee members from KSLU, One from outside, Director Physical Education of KSLU as chairman of selection committee and Principal of the host college will be the convener to constitute KSLU team to participate in Inter University Tournaments.
- g. It was resolved to appoint one Coach and one Manager for coaching camp and both to escort the KSLU Team in Inter University Tournaments.
- h. It was resolved a maximum of 6 students are permitted to attend the University Blue selection trials from each college.



- i. It was resolved to continue to provide the University Blues participating for the Second Time a Cash Award of Rs. 2000/-, Third Time Rs. 3000/-, Fourth Time Rs. 4000/- and Fifth Time Rs. 5000/-respectively for 2015-16.
- j. It was resolved not to levy any entry fees for University Blue Selections.
- k. It was resolved that Physical Education Director of the host college will be the manager for university team.
- I. It was resolved to provide Badminton Cock, balls, etc., by KSLU for hosting Inter University Selection trials to the host colleges.
- m. It was resolved University Blue Cricket Selections will be held at KSLU, Hubballi.
- n. It was resolved to continue to provide the Students securing 01<sup>st</sup> to 08<sup>th</sup> Place in All India Inter University Competition in individual events an awarded of Rs. 1,00,000/- for each Student.
- o. It was resolved to continue to provide the teams securing 1<sup>st</sup> to 4<sup>th</sup> place, in South Zone Inter University Tournament in Team events an awarded of Rs. 2,00,000/- to be distributed equally among Students, Coach & Manager.
- p. It was resolved that in case some extra ordinary students want to participate in the individual events and team events which are not covered in the para No. 2 a, a committee of two Sports Advisory Committee Members, one event specialized expert and Director Physical Education will take a decision to participate with higher authorities to send the team.
- q. It was resolved to continue to provide the host college with existing Rs.10,000/-for hosting University Blue Selections.

#### 3. POINT SYSTEM:

It was resolved to continue the existing Point System Rules of previous year.

- a) Memo will be issued for non-participation.
- b) First to Third Ranked College Winners of last year will not get chance for next Three years.
- c) Slab points for standard and quality 850, 750 & 650 points for First, Second & Third place.
- d) No slab for Fourth to Sixth place.
- e) 20 negative points for Managers absence.
- f) 50 negative points for indiscipline team.
- g) 3 years ban for inclusion of other than registered college students.
- h) Each team participating in Inter Collegiate Meet, Men and Women events will be awarded 25 points each.
- i) Winning Team in Inter Collegiate will get 20 points
- j) Runners in Inter Collegiate will get 15 points.
- k) Third place in Inter Collegiate will get 10 points.
- 1) Fourth place in Inter Collegiate will get 5 points.
- m) Physical Education Director/Manager escorting the team will be awarded 20 points
- n) University Blue per student will get 25 points each.

- o) Hosting the Inter Collegiate Competition 25 points for men and 25 points for women.
- p) Hosting the Selection trails will get 25 points.
- q) Attending the University selection Trails will get 10 points per student.
- r) KSLU's Law School, Navanagar, Hubballi is exempted from the cash award.
- s) Trophies & certificates will be issued for First to Sixth Ranks.
- t) To distribute Sports Equipments to the winners/Ranked Colleges in Point system since 2012 to 2016 by inviting E-Tender existing amount as shown below.

### 4. INTER COLLEGIATE:

- a. It was resolved to continue to provide the Athletes who Create a new record in Athletic meet a cash award of Rs 5000/- in case many athletes break the record, only the person securing First place will be rewarded.
- **b.** It was resolved to continue to provide the Best Male and Female Athlete in Athletic meet with a cash award of Rs 10,000/- each. In case of tie, the same amount shall be shared.
- c. It was resolved not to levy any entry fees for Inter Collegiate Tournaments.
- **d.** It was resolved that host college will provide Food & Accommodation to all the participants and managers. The University shall bear these expenses as per norms.
- e. It was resolved that Medals, Trophy's and Certificates will be provided by KSLU for Inter Collegiate competition.
- **f.** It was resolved that each college must participate in at least 3 Inter Collegiate Tournaments.
- g. It was further resolved to recommend to University to increase per day boarding and lodging charges per student / manager per day from Rs. 200 to Rs. 250 to be paid to the host colleges who conduct inter Collegiate Tournaments. It was further resolved to recommend to the University to increase the amount of expenditure from Rs. 10,000/- to Rs. 15,000/- to colleges which organise inter Collegiate Competitions and from Rs. 30,000/- to Rs. 50,000/- to colleges which conduct Inter Collegiate Cricket Tournaments.
- h. It was resolved that Host College should arrange a clinic in their respective Game at the existing honorarium of Rs. 1,000/- to be borne by KSLU.
- i. It was resolved that Inter Collegiate Athletic Meet will be held in Single Zone at KSLU.



- j. It was resolved to provide T-shirt, Shots, Caps, TA, Good Nutrition food such as Milk, Egg, Fruits and quality Dinner in Inter-Collegiate Athletic Meet.
- k. It was resolved to conduct the following sports/games at the collages that voluntarily sent letter and accepted to host as mentioned below on the dates specified against them Director Physical Education will allot other Inter Collegiate Tournaments to the Colleges with the permission of higher authorities.

- L. It was resolved to issue the circular to all the colleges and invite them to host intercollegiate tournament and host university selection.
- M. It was resolved to introduce Kabaddi (women) and Kho Kho (Men and Women) minimum 8 teams.

## 5. GENERAL:

- a. It was resolved to provide existing Rs. 100/- as local conveyance Charges for each Student, Coach, Manager, Selection Committee Members, Convener, Sports Advisory Committee Members, Physical Education Directors, Director Physical Education, and all other officers and students authorized by KSLU.
- **b.** It was resolved to reserve one seat for sports quota in Admission for Law Courses. Proposal will be submitted to KSLU for considering one percentage.
- c. It was resolved to provide a Gold Medal or scholarship for the best outgoing Sportsperson at Inter Zonal Athletic Meet every year.
- d. It was resolved to obtain consent of Parents and Principals of students for participants in competition.
- e. It was resolved to provide Insurance for the University Blues participating in competitions, by the respective college principals.

- f. It was resolved to permit a Junior Assistant from sports section to assist Director, Physical Education of KSLU in Inter Collegiate Tournaments & selections trials. TA / DA shall be paid to him as per KSLU norms.
- g. It was resolved to host National Conference in Sports at KSLU.
- i. It was resolved that Summer Coaching camp with selected Students from each College will be conducted at KSLU for 10 to 15 days.
- j. It was resolved that existing KSLU's Law School Students TA/DA will be same as University Blues and to provide a set of T-Shirt for participating in Inter Collegiate Tournaments.
- **k**. It was resolved that Daily one period of Physical Education to be included in the Time Table.
- I. It was resolved to Purchase of Sports Equipments worth of Rs. 1,00,000/- for the year 2016-17.
- m. It was resolved to Purchase of Uniforms for University Blue's and KLSU Law School.
- n. It was resolved to Purchase of Trophies and Medals and Certificate for Inter-Collegiate Tournaments.
- o. It was resolved to Purchase of Equipments required for Inter Collegiate Athletic Meet.
- p. It was resolved that 400 Mtrs Track on the Campus, a Multi Purpose Indoor Hall, 2 Volleyball Court, 2 Tennis Courts, Multi Gym Hall within the Campus to be built phase wise within 1 crore under infrastructure found.
