

**STATUTE GOVERNING POWERS AND FUNCTIONS OF  
SCHEDULED CASTE AND SCHEDULED TRIBE STUDENTS  
WELFARE AND GRIEVANCES COMMITTEE**

Statute relating to the Scheduled Caste and Scheduled Tribe Students Welfare and Grievances Committee under section 43 of Karnataka State Law University Act 2009.

**1. Title and Commencement:**

- a) This Statute may be called as "the Statute relating to the Scheduled Caste and Scheduled Tribe Students Welfare and Grievances Committee, 2010".
- b) It shall come into force from the date of assent of the Chancellor.

**2. Constitution of Committee:**

The Scheduled Caste and Scheduled Tribe Students Welfare and Grievances Committee shall consist of the following members namely:

- i) A Syndicate member nominated by the Syndicate to be the Chairman of the Committee.
- ii) Two Syndicate members nominated by the Syndicate.
- iii) One Academic Council Member.
- iv) One lady member from the faculty.
- v) The District Social Welfare Officer for backward class and minorities.
- vi) The District Social Welfare Officer for Scheduled Caste.
- vii) The District Social Welfare Officer for Scheduled Tribes.
- viii) The Dean, Students Welfare as the Ex-Officio Member Secretary.

**3. Tenure:**

- a) The tenure of the Ex-officio members shall be permanent.
- b) The tenure of office of members nominated by the Syndicate shall be two years on rotation.

**4. Meetings of the Committee:**

The Committee shall meet ordinarily once in 3 months and at other times when conveyed by the Vice-Chancellor.



5. The Sub-Committee shall have the power to make recommendations to Syndicate regarding.

- a) Welfare schemes like hostels and scholarship etc.
- b) Any other subject which will be helpful to the students.
- c) To review periodically and recommend to the Syndicate all other matters connecting to the welfare of the SC/ST Backward class and minority students of the University.

**6. Repeal and Savings Clause**

- (a) Any Statute existing hereinbefore governing the powers and functions of the Scheduled Caste And Scheduled Tribe Students Welfare and Grievances Committee stands repealed.
- (b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid and remain in force notwithstanding anything contained in this Statute.




