

**NOTIFICATION**

In exercise of the powers conferred under Sec. 47 read with Sec. of the Karnatal State law University Act, 2009 (Karnataka Act No : 11 of 2009), the Syndicate of Karnatal State Law University hereby makes the following Statute, namely :-

**1. TITLE AND COMMENCEMENT**

- a) This Statute shall be called as the "Statute governing Award of University Research Studentships"
- b) This Statute shall come into force from the date of assent of the Chancellor.

**2. PURPOSE OF AWARD**

The University provides an opportunity to students to undertake research at doctoral level in various disciplines of law in the University.

**3. NUMBER, VALUE AND DURATION**

- a) The University Research Studentships available for award shall be one for each of the Disciplines of law in the University. The value of the studentship shall be as prescribed by the Syndicate from time to time.
- b) The duration of the University Research Studentships shall be for a total period of three years. One year for M. Phil. and two years for Ph.D. Students, and three years for students admitted for Ph.D. directly after LL. M.

**4. ELIGIBILITY**

The candidate holding first or second classes LL. M. Degree (with minimum of 55% marks) at first appearance in the subject of their research are eligible for award of Research studentship.

**5. CONDITIONS OF AWARD**

- (a) The candidate shall be selected for award of University Research Studentship on the basis of merit. The selected candidate has to register his or her name before joining the research work. The award shall be effective from the date of joining the research work.
- (b) In case, the registered candidate is awarded Studentship the award shall be effective from the date of joining.
- (c) The scholar will do whole time Research work under approved Guide in a subject selected by him/her and agreed by the University.
- (d) The scholar shall not accept or hold any appointment paid or otherwise or receive any emoluments, salary, stipend etc. from any other source during the tenure of the award.
- (e) The Research Scholar shall complete the full period of research work viz. three years. In the event of a scholar discontinuing before the completion of the period for no valid reasons and without prior approval of the University, he shall be liable to refund the entire scholarship amount received by him/her.

- (f) The scholar shall present to the University through his Supervisor and Chairman, Department of Studies concerned or the Director of KSLU Law School, a satisfactory progress report, once at the end of the each term. He shall before the expiry of the tenure of the Scholarship, submit to the University, a comprehensive report of the work done during the award.

#### 6. LEAVE

- (a) A maximum period of thirty days in a year in addition to general holidays may be taken by a scholar as leave with the approval of Supervisor, the Chairman and the University. The general holidays, however, do not include the vacation period i.e., summer, winter and other vacations. No other leave with scholarship will be admissible to a scholar.
- (b) The scholar may in special case, be allowed by the University leave without scholarship for a period not exceeding three months during the tenure of the award on the recommendation of the supervisor and the Chairman of the Department concerned or the Director of KSLU Law School. However, on this ground tenure of the Scholarship will not be extended.
- (c) The scholar shall undertake teaching work of four hours per week in the Department.


#### 7. PAYMENT

- (a) The scholarship amount due to the scholar shall be paid monthly on a bill signed by the student concerned and counter signed by the Supervisor and Chairman of the Department in which he is studying. Such a bill shall have the usual report of the Supervisor and Chairman of the Department regarding progress, attendance and conduct of the student concerned.
- (b) The decision of the University shall be final in all matters concerning awards.

#### 8. REPEAL AND SAVINGS CLAUSE

- (a) Any Statute existing hereinbefore governing Award of University Research Studentship stands repealed.
- (b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Statute.
