

THE KARNATAKA STATE LAW UNIVERSITY, TEACHING STAFF RECRUITMENT STATUTE 2010.

(Statutes under Section 30(i) and (vi) and 46(11) read with Section 64 of the *Karnataka State Law University Act, 2009*)

1. Title and Commencement: (1) This Statute may be called as "The Karnataka State Law University, Teaching Staff recruitment statute 2010.

(2) This Statute shall come into force from the date of the assent of the Chancellor.

(3) This Statute shall apply to all Teaching Posts and appointments in the University.

2. Definitions : In this Statutes unless the context otherwise requires:-

(a) Act means: The Karnataka State Law University Act 2009 (Karnataka Act 1 of 2009)

(b) The words and expressions referred to in this Statute and not defined shall have the same meaning assigned to them in Government Order No. ED 37 UNE 2009 Dated 24th day of December, 2009 and Government Order No. ED 37 UNE 2009 Dated 26th day of December, 2009.

3. In respect of the category of posts specified in column (2) of the Schedule below, the scale of pay shall be as specified in column (5), the number of posts in column (6), the method of recruitment and the minimum qualification shall be as specified in columns (7) and (8) thereof namely:-

Applicability of other rules:- Subject to the provisions of this Statute, the provisions of the Karnataka General (Recruitment) Rules 1977, and the Karnataka (Probation) Rules 1977, the Statutes, the Ordinances, Regulations and Rules made there under and the UGC guidelines issued from time to time shall be applicable with such modifications as the Syndicate may from time to time determine.

Provided that there shall be no maximum age limit for the category of posts specified under this statutes.
