**STATUTE RELATING TO THE ESTABLISHMENT OF KARNATAKA STATE
LAW UNIVERSITY'S LAW SCHOOL**

In exercise of the powers conferred under Sections 3 (4), 5, 47 read with Section 46 of the Karnataka State Law University Act. 2009, the Syndicate of Karnataka State Law University, Hubli hereby makes the following Statute namely:

1. TITLE AND COMMENCEMENT

- a. This Statute may be called as "Statute Relating to the Establishment of Karnataka State Law University's Law School".
- b. It shall come into force from the date of assent of the Chancellor.

2. ESTABLISHMENT

There shall Karnataka State Law University's Law School established in the main campus of the University at Navanagar, Hubli.

3. FUNCTIONS

- a. The Law School shall conduct academic programmes of Under-Graduate, LL.B. Degree, Post-Graduate, M.Phil, Ph.D. Courses, Diploma and Certificate Courses in Law as prescribed under relevant Statutes, Ordinances, Regulations and Rules made under the Karnataka State Law University Act. 2009.
- b. It shall undertake legal service and legal literacy programmes in the Karnataka State.
- c. It shall undertake research projects in cutting edge knowledge of law with the support of various funding agencies of Union and State Government and other agencies.
- d. It shall undertake publication of KSLU's Law Journal, Newsletter, KSLU Students' Law Journal, Reading Material for various courses, Text Books, Reference Books, Monographs etc.
- e. It shall conduct Seminars, Workshops, Conferences, Symposia etc., on the emerging trends in the field of law periodically to update the knowledge in law to all stake holders.
- f. It shall enter in to a Memorandum of Understanding with the sister institutions in India and at abroad, which are involved in similar activities for exchange of resources, faculty, students and conducting of research activities jointly.

- g. It shall conduct orientation and refresher courses to provide necessary inputs to the teachers in the University and to the affiliated colleges.
- h. It shall conduct short term training programmes to the cross sections of the society in the areas of laws relevant and required for the concerned community.
- i. It shall organize special Lectures from experts in the field of law and allied areas for law students.
- j. It shall supervise the activities of Law Colleges coming under the jurisdiction of the University in development of the Legal Database for Karnataka State.
- k. It shall strive to establish collaborations with the Karnataka Legislature, Karnataka Judicial Academy, Karnataka Institute for Law and Parliamentary Reform, Karnataka Human Rights Commission, Karnataka Law Commission, High Court of Karnataka, Karnataka Legal Service Authority, Karnataka Lawyers Academy, Karnataka Administrative Tribunal, Lokayukta, Karnataka State Consumers Forum, Administrative Training Institutes, Police Training Institutes, Forest Training Institutes etc to promote quality of legal education and legal profession.
- l. It shall conduct periodical curriculum development meetings to update curricula of various courses in law in the University and in affiliated law colleges.
- m. Generate Prospectus, Folders, Leaflets etc to attract students to various courses conducted by the School.

4. STRUCTURE

- a. The Karnataka State Law University's Law School shall consist of the following sections in Law:
 - i. Under-Graduate
 - ii. Post-Graduate
 - iii. Diploma
 - iv. Certificate Course
 - v. M.Phil, Ph.D.
 - vi. ILTCS (Institute of Legal Training Consultancy and Services)

- b. Each section shall be headed by a coordinator who is a teacher of the rank of a Professor or Associate Professor and assisted by such other staff as assigned to it by the Director with the approval of the Syndicate.
- c. Every section shall function, in coordination with the other sections.
- d. Faculty shall be common for all sections and share the work load as determined by the School Council consisting of entire faculty.

5. THE FACULTY

The faculty of the school shall consist of:

- a. Assistant Professors, Associate Professors and Professors assigned to it by the University.
- b. Adjunct Professors.
- c. Honorary Professors.
- d. Part-time Teachers.
- e. Professor *Emirates*.

6. THE DIRECTOR

- a. The Karnataka State Law University's Law School shall be headed by the Director.
- b. The Director shall be appointed by the Vice-Chancellor with the approval of the Syndicate from among the Professors of the University on the basis of Seniority cum Merit on rotation basis.
 - Provided that, if no Professor is available, a Associate Professor may be appointed
 - Provided further that, if no Associate Professor is available, an Assistant Professor may be appointed.
- c. The term of office of the Director shall be three years on date of superannuation or if he/she removed from the post of Director vide clause (e), whichever is earlier.
- d. He shall be assisted by such other staff as required and approved by the Syndicate.
- e. **Removal of Director :**

The Director can be removed from his post by the Vice-Chancellor with the approval of the Syndicate if he/she commits following irregularities and the charges are proved as per the rules and Statutes in force.

- i. Misappropriation of University or Law School funds or property.
- ii. Falsification of records, gross irregularity and negligence in discharge of official duties with a dishonest motive, misuse of official position.
- iii. Misconduct, Misbehaviour as per the Karnataka Civil Service conducts rules.

7. FUNCTIONS OF THE DIRECTOR

- a. The Director shall be the administrative and academic head of the Law School. He/She shall be responsible for the smooth conduct of the academic and other activities of the School.
- b. He shall supervise the work of the teaching and non-teaching staff assigned to the School.
- c. He shall conduct, monthly meeting of the faculty to review the work.
- d. He shall conduct week end meeting, of the Coordinators of various sections to review the functioning of the sections.
- e. He shall ensure discipline among the students.
- f. He shall constitute Parent Council and meet them regularly and to brief about the student activities.
- g. He shall promote the Alumni Association of the School.
- h. He shall constitute the Union and Gymkhana of the School and to supervise the functions of these bodies.
- i. He shall perform such other functions as assigned to him, by the Vice-Chancellor and by the other Authorities of the University from time to time.


8. MISCELLANEOUS

- a. Annual Report of the School shall be prepared, under the supervision of the Director and submitted the same to the University for its Approval.
- b. Law School shall work closely with all Law Colleges and Institutions affiliated to the University and Autonomous Colleges and Institutions coming under the jurisdiction of the University as a partner on equal footing to promote quality in legal education in the State of Karnataka.
- c. Law School shall advise the University in the matters of improving the quality of legal education.
