This offer is purely provisional subject to fulfillment of all eligibility criteria both Academic Qualifications and category certificate (if any).

It the time of physical reporting at IIT Kharagpur or as asked at a later stage, you will be required to produce (a) original certificates and mark-sheets of your educational qualifications, (b) evidence of the work experience, if any (c) category certificate (EWS/OBC-NCL/SC/ST/PwD), if applicable, issued by the competent authority (d) A person who is in employment and selected for admission, he/she can either resign and produce the acceptance of resignation by the employer at the time of joining or he/she can submit 'No Objection Certificate' along with santioned leave from the employer for the entire course duration.

Please note that all the candidates must have a minimum of 60% marks (or a CGPA of 6.5 in 10 point scale) in the final qualifying examination for GE/EWS/OBC-NCL categories and 55% marks (or a CGPA of 6.0 in 10 point scale) for SC/ST/PwD categories. The CGPA will not be converted into percentage marks if the degree awarding Institute provides marks in CGPA system. Their admission will be based on the CGPA awarded in the transcript. No conversion of percentage of marks into CGPA and vice-versa will be accepted. The details of submission procedure will be intimated to all candidates at a later date. 




