

FOREWORD



It is my pleasure to brief about the Karnataka State Law University, which is located in between Hubballi and Dharwad i.e. Navanagar, Hubballi. The University was established in 2009 under a separate legislation i.e., Karnataka State Law University, Act, 2009. Under the Act the Law University has jurisdiction over all the Law Colleges which are affiliated to University. At present 110 Law Colleges (both Grant in Aid and Government Law Colleges) are working under the jurisdiction of the Law University which are spread over the entire State of Karnataka. The objective of the Law University is to inculcate and to impart quality Legal Education to the Society.

KSLU's Law School

The Law University has its own constituent Law College called "KSLU's Law School" which is headed by the Director who is responsible to execute all the Academic activities of the Law School. Presently the Law School has 19 Full time Law Teachers in different cadres imparting Legal Education. The constituent Law School of the Law University is offering Five Years Integrated Law Programme of B.A., LL.B.(Hons. course), B.B.A., LL.B.(Hons. course). Two years Post-Graduate Programme of LL.M. in Constitutional Law; Criminal Law; and Intellectual Property Law. Few Diploma Courses are also being taught along with research programmes like Ph.D., M.Phil, etc.

Library

The Law University has a good library having more than 35,000 Law books, and substantial number of law reports and academic journals to meet the needs of the students and teachers. The library has also providing facilities like, online data like West Law India, Hein online, Infilbnet, Manupatra etc. The library also has good reading room facility for the students and teachers. Shodhganga software is being used to upload the research reports and Ph.D. thesis.

The Law University has a separate examination wing with modern technology to evaluate the answer scripts and to announce the examination process including announcement of the result is

well maintained. All affiliated law colleges of Karnataka State Law University (KSLU) are conducting Law examination to the students according to the Law University guidelines and regulations.

Sports

The University is also having a separate sports wing to promote sports activities for the students and teaching and non-teaching staff. The University regularly conducts sports activities such, Volleyball, Badminton, Chess, Athletics, Kabbaddi, Throw ball, Tenikoit (ring), Basketball and Cricket. The University periodically conducts selection of students to represent University in South Zone and all India Inter University Tournaments. Apart from the above sports activities, the University is also promoting Karate, Taekyondo, and KickBoxing. All India Net Ball event is also conducted by the University.

College Development Council

The University is also having College Development Council (CDC) headed by a Director, who is responsible to carry on the college development activities of all the affiliated law colleges of the University. The CDC undertakes the process of conducting Local Inspection for all the affiliated law colleges in the beginning of every year. Based on the Local Inspection Committee report, the colleges are recommended to obtain Bar Council of India approval for the affiliation given by the University. The CDC also insists every affiliated law college to subject themselves to National Assessment conducted by the NAAC, Bangalore.

National Service Scheme

The University has NSS Cell and Legal Aid Cell to promote social services to the society by identifying few villages. All the affiliated law colleges including Law School of the KSLU have established their own NSS units in their respective colleges. All the NSS units of the affiliated law colleges and Law School conduct regular programmes such as, Legal Awareness Programme, Legal Aid Programme, Tree plantation, Blood Donation, Health Checkup, Rain water harvesting and Environment Awareness Programmes.

Scheduled Caste and Scheduled Tribe Cell

The University has SC/ST cell headed by the co-ordinator to execute the work of the programmes and activities conducted for the benefit of the SC/ST students and teachers. The cell is also working for getting regular Government of India scholarships, laptops and special

grants for the purchase of books exclusively for the SC/ST students. The co-ordinator of the SC/ST cell is in regular touch with the department of social welfare.

Right to Information Cell and ICT Cell

The University also has established Right to Information (RTI) cell headed by a co-ordinator. The cell provides required answers and replies to the complainants who file RTI applications. The “Women Grievance Cell” is also functioning effectively to resolve the problems of girl students and lady employees. To monitor the activities of the cell, a senior lady Professor is given incharge. The University is also having ICT cell headed by an Assistant Programmer who could monitor the Internet linking facility, Wi-Fi facility and University website in addition to the computer lab.

Engineering Division

Engineering Division is also established in the University which looks after the maintenance of all the buildings and construction, renovation and repair works. The Engineering Division is headed by Executive Engineer and Assistant Executive Engineers deputed from Public Works Department, Government of Karnataka. The boys and Girls hostels, staff quarters, Vice-Chancellor Quarters, Registrar and Registrar (Evaluation) Quarters also maintained by the Engineering Division. The Access roads, Lawning, Electricity work are going on within the Law School campus.

Internal Quality Assessment Cell

The IQAC Cell of the University is the important wing which undertakes all academic activities of the Law School and the University. Every year the co-ordinator of the IQAC collects information relating to Research, Teaching, Evaluation, Extension Programme, activities done by the SC/ST Cell, etc. IQAC wing of the University is responsible in preparing SSR and to be submitted to the NAAC for inspection.

Planning and Monitoring and Evaluation Board

Planning and Monitoring and Evaluation Board is an important wing of the University which undertakes the research activities, research programmes, sends research Proposals to the various funding bodies. It also gathers information about the future planning of the University. It also focuses on the evaluation of the various departments and subjects them to evaluation by the Expert Committee. It plays an important role in participating with NIRF Ranking conducted through Survey in the entire county.

Research Centres

The University has two Research Centres.

1. Centre for Constitutional Governance and Democracy 2. Centre for Water Law. These two centres are headed by the Senior Professors of the University who can conduct survey of water sustainability through Research Scholars. Minor Research Projects are taken up to fund the water quality, its sustainability, problems of ground water and surface water.

Chair

The University has established Vignaneshwara Chair headed by a retired Supreme Court Judge to look after the research work of the centre. The Centre also conducts workshops and seminars on the importance of the principles of Vignaneshwara.

I submit my deepest gratitude to all the statutory officers, teachers and non-teachers for your co-operation in consolidating the informations relating to 2022-23.

The Legal Education Committee at its meeting held on 22nd August 2009 considered the inspection report of above mentioned University and Committee made the following recommendations;-

“Legal Education Committee considered the inspection report of Karnataka State Law University, Hubli and its School of Law submitted by the inspection team of the Bar Council of India. After consideration Committee is of the view that the recognition to Karnataka State Law University, Hubli under Section 7 (1) (i) of the Advocates Act, 1961 be granted for the purpose of conferring the degree of law in respect of LLB Three year law Course, B. A. LLB Course and B. B. A LLB Five Year integrated Degree Courses and temporary approval of affiliation to School of Law, Karnataka State Law University, Hubli be also granted with intake of one section of 60 students for imparting B. A. LLB five year integrated course and one section of 60 students in B. B. A LLB Five Year integrated Degree Courses for a period of two years i.e. 2009-2010 to 2010-2011 subject to the condition that:-

1. Admission of the students be made strictly only on merit basis.
2. University authority must submit the list of law colleges comes under its jurisdiction.
3. Before starting the admission process of the students the institution should try to get the approval of statute and ordinance from the State Govt.”

The above recommendations were considered by the Bar Council of India at its meeting held on 23rd August, 2008 and accepted the same.

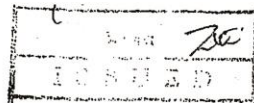
