THE PROCEEDINGS OF THE MEETING ARE AS FOLLOWS:

1. The Committee unanimously decided to confine various activities and budgetary provisions of the SC-ST CELL, prepared for the financial year 2022-2023 to the students, research scholars and teachers of KSLU's Law School.
2. The Committee unanimously decided to prepare budgetary provisions extending it to affiliated colleges hereinafter and until such budgetary provisions the current activities and budgetary provisions shall applicable only for KSLU Law School.

3. It was unanimously decided to remove following programs from the list of the activities prepared for SC-ST Cell of the University: (1) To organize moot court competition for the SC-ST Students.
4. It was unanimously decided to supplement following programs to the existing programs of SC-ST Cell of the University:
 1. To provide financial assistance to submit dissertation by LL.M Students.
 2. To provide prize money to the children of SC/ST Employees of the University who secure first class in SSLC, PUC, Graduation and Post-graduation degree.
 3. To constitute fellowship for Ph.D students of the University. (From the next budget)
 4. To conduct Brainstorming session for SC-ST law graduates.
 5. To provide financial assistance to the SC-ST Teachers to attend Refresher/Orientation/Short Term Courses.
5. The Committee unanimously decided to conduct following programmes before the end of the financial year 2022-23:
 - ✓ 1. Purchasing Books worth of Rupees 5 Lakh for the SC-ST Students to provide book bank facility in the Karnataka State Law University Library for the SC/ST Students.
 2. Providing Financial Assistance of Rupees 2500/- to each eligible SC-ST LL.M, students of KSLU's Law School for submission of dissertation.
 3. To provide prize money to the SC-ST Students who represented University in sports and cultural events at university and national level.
 4. To arrange educational tour for the final year SC-ST Students of KSLU's Law School to visit High Court.
 5. To conduct coaching programme of competitive exams for SC-ST Students of KSLU's Law School.
 6. To provide room rent to the SC-ST Students of KSLU's Law School who are unable to get hostel facilities in the University.
 7. To celebrate "World Day of Social Justice" 2023 and conduct competition such as Debate, Poster Making, 'Stand-up Comedy', 'The Cultural Gala,' on social justice topic.
