**Report on Short Term Translation Workshop**


Karnataka State Law University organized a 14-hour short-term translation training workshop (one credit course) from 13.07.2021 to 20.07.2021 to help Kannada legal writers, translators and aspiring candidates to become judges under the scheme to deliver justice in Kannada to common people. The main objectives of this training workshop are to provide information on the use of appropriate Kannada words for English or Latin words and phrases, proper translation training for different laws, administrative orders, and court judgments, and other writings into Kannada, as well as documents in Kannada, and court judgments into English. It was to provide guidance and training.

Inauguration of this workshop on 13.07.2021 at 3.15 pm by Dr. Jinadatta G. Desai, Retired District Judge, Belagavi conducted the inauguration ceremony as the chief guest. C. N. Ramachandran, retired English professor and translator, Bangalore and Mr. T. S. Nagabharana, Chairman, Kannada Development Authority Bangalore had arrived. Presided over by Prof. (Dr.) IshwaraBhat, Honorable Chancellor, K.R.K.V. Hubli was in charge. Prof. (Dr.) Ratna R Bharam Gowdar welcomed the guests and Mrs. Archana K. He had completed the introduction of the guests. Dr. Bhimabai Mulaga offered the salutation.

A total of 14 lectures have been designed in this short term workshop as two lectures per day, the one hour lecture of the first half of each day will be lectures (technical trainings) on translation by legal linguists and the second part lecture will be designed to impart practical knowledge and training to the participants.

During the technical lecture, general topics such as concept, theory and principles of translation, types and problems of translation, and information about aspects such as language purity, grammar, Kartari and Karmani experiment to be emphasized while translating from English to Kannada and from Kannada to English were given by resource persons Shri. 



