5. There is an accessible, active, unbiased and Confidential Grievance Redressal Cell.

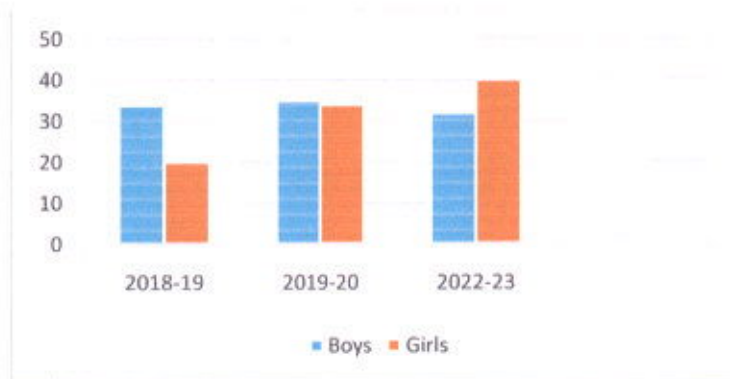

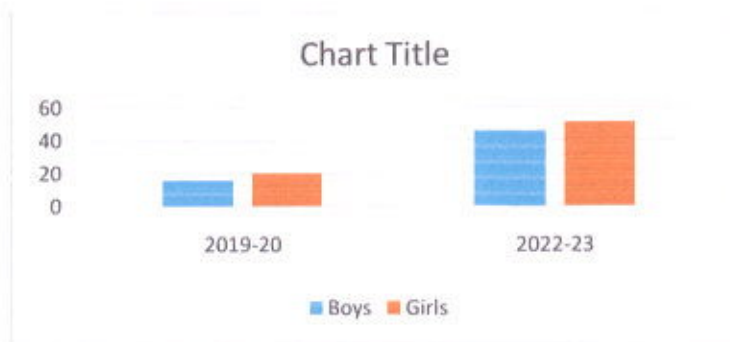
OBJECTIVES

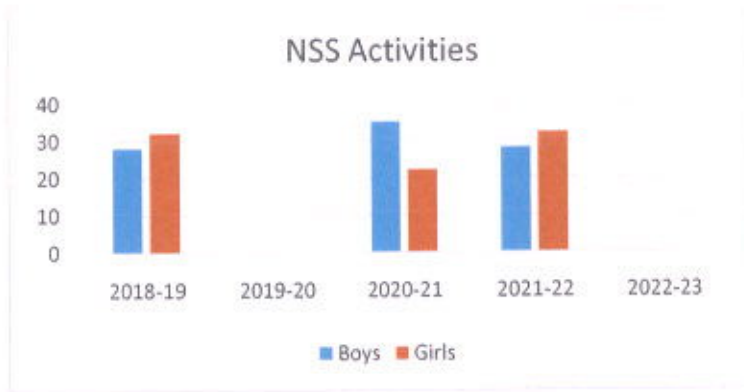
Admission to KSLU's Law School



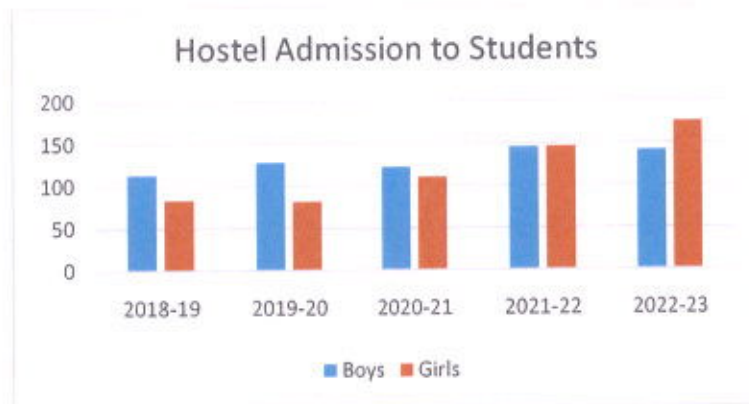

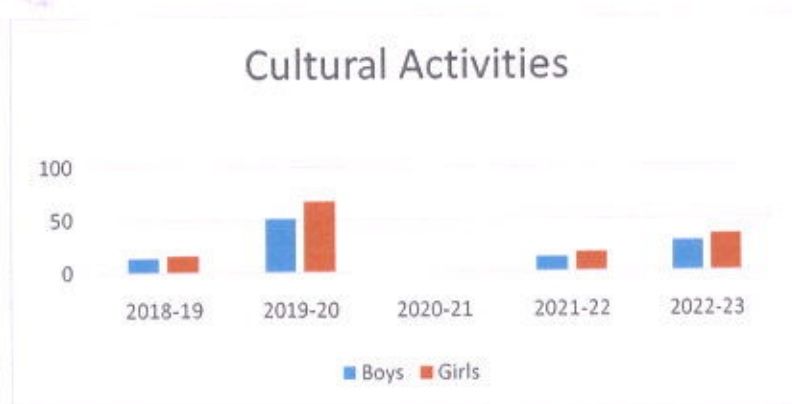

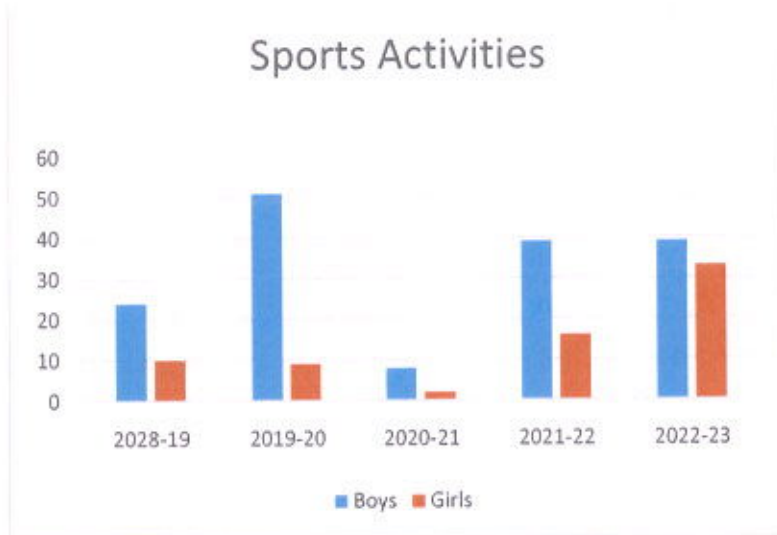
