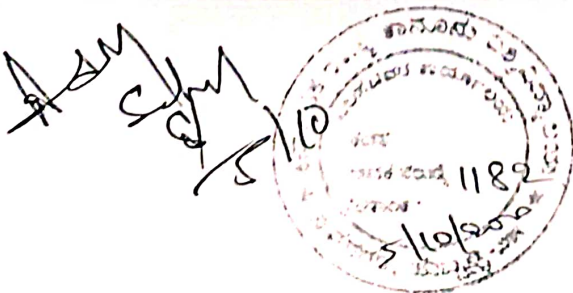

**Statute relating to Establishment of "Vijnaneshwara Adhyayana Peeta" at the  
Karnataka State Law University, Hubballi**

**PREAMBLE:**

The Hon'ble Chief Minister of Karnataka Sri. B. S. Yediyurappa while presenting budget in March 2020 has announced that "Vijnaneshwara Adhyayana Peeta" will be established at a cost of Rs 1 crore in Karnataka State Law University, Hubballi, for carrying out research on great personalities of Karnataka.

This provides a unique opportunity to the Karnataka State Law University to undertake focused research about the great personalities of the state who have made invaluable contribution from ancient to contemporary periods to the field of law and justice.

Eminent scholars who have made contribution to the field of law may be invited to Chair the Adhyana Peeta. The University shall select an eminent academician or retired judge or professor to work as the Chair Professor of the Adhyana Peeta. He will deliver special lectures at the University and also undertake research. The Adhyana Peeta will also undertake research projects and document contributions of legal luminaries from Karnataka, organised seminars, conferences, etc and bring out publications to contribute to the field of knowledge. This will be of immense help for the students of Karnataka State Law University.

In order to establish the "Vijnaneshwara Adhyayana Peeta" a set of Statutes is framed as follows in exercise of powers conferred by Sec.5(xi), Section 46 (8) read with section 47 of the Karnataka State Law University Act 2009, the syndicate makes the following statutes.

**1. Title and commencement:**

- a. These Statutes may be called, "Vijnaneshwara Adhyayana Peeta (Vijnaneshwara Study Chair) Statutes, 2020".

- b. They shall come into force from the date they are assented to by the Chancellor.

## **2. Definitions:**

- a. "Act" means the Karnataka State Law University Act, 2009.
- b. "Chair Professor" means an eminent academician or retired judge or professor who is appointed as the Chair Professor of the Vijnaneshwara Adhyana Peeta.
- c. "University" means "The Karnataka State Law University, Hubballi".
- d. All other words used in these Statutes shall carry the same meaning as assigned to them in the Act.

## **3. Organisation of the Adhyana Peeta, Staff and Selection:**

- a. It shall be headed by a Chair Professor
- b. There shall be such number of research assistants appointed as the University decides from time to time.
- c. The "Chair Professor" shall be selected only from among distinguished scholars with national/international recognitions and professors with proven academic record, retired Supreme Court or High Court Judge who has made a significant contribution to academics.
- d. The Procedure of selection shall be as follows: A selection committee consisting of the Vice Chancellor as Chairman, three Vice Chancellors nominated by the Syndicate and the Registrar as member secretary may be constituted to select/invite Chair Professor.
- e. There shall be no age bar for consideration of Chair Professor.

f. The procedure for selection of Research Assistants shall be as follows:

- i. A notification shall be issued inviting applications for the post of Research Assistant.
- ii. The qualification for Research Assistant shall be Master of Laws with proven research abilities manifested in publications.
- iii. A committee with the Vice Chancellor as Chairman, Two Professors (one internal and one external) of the University as members and the Registrar as member secretary shall be constituted to select the research assistants.
- iv. The office staff and sub staff shall be provided by the University

#### 4. Functions:


- a. The Adhyana Peeta will undertake research in the fields as approved by the University. It shall prepare proposals to undertake research relating to the contributions made by great personalities of Karnataka to the field of law and submit them for the approval of the University.
- b. The Chair Professor shall deliver at least four specialized lectures for the students/faculty members;
- c. Aid conceptualization of new research areas and development of research projects by the faculty and students of the University;
- d. The Adhyana Peeta shall also undertake research projects and document contributions of legal luminaries from Karnataka, organise seminars, conferences, etc
- e. Bring out publications to contribute to the field of knowledge.
- f. All or any of the functions as may be directly suggested by the Vice-Chancellor.

## 5. Privileges, honorarium, salary:

- a. The Chair Professor will be treated as an 'honoured' member of the University and shall be an honorarium of Rs.111 Lakh (Rupees one lakh only) per annum or such honorarium as may be prescribed by the University from time to time. He/she shall not be paid any salary.
- b. He/she may also be extended adequate library facilities for proper pursuance of his/her research.
- c. The Chair Professor, who is invited to the campus from outside, shall be entitled for payment of TA, Guest House accommodation and local hospitality. Apart from this, there would not be any other financial commitment on the part of the University.
- d. The Chair Professor, who is having a Research Project or assignment from any funding agency having a provision of honorarium and contingency, shall be entitled to the same. Research Projects/schemes brought by the Distinguished Professor himself/ herself shall be carried out by him/her independently through the University.
- e. Distinguished Professor shall be provided with routine medical facilities at the Health Centre of the University free of charge in case of exigencies during his/her stay on the campus. He/she may also be eligible for all other medical benefits available to other in-service Professors of the University.
- f. If a retired Professor of the University staying in quarters is selected as a Chair Professor, he shall not be eligible to retain the quarters.
- g. The Research Assistant shall be paid a salary of Rs.20,000/- (Rupees Twenty Thousand only) per month or such salary as may be prescribed by the University from time to time.

5. Funds:

- a. The activities of the Vijnaneshwara Adhyana Peeta shall be funded from the interest that accrues on the capital funds that are made available by the Government of Karnataka and such other philanthropic institutions which shall be deposited in the banks decided by the University.

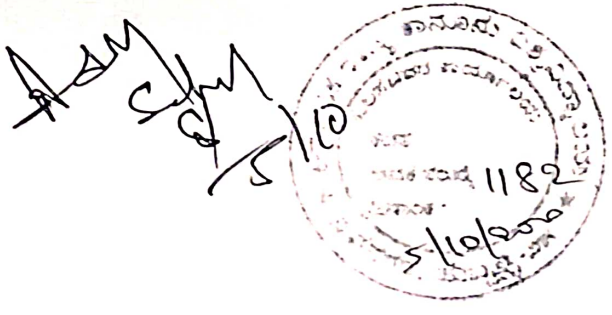


