Hon'ble Vice-Chancellor informed Research Assistants are doing minor researches and UGC funds have not been obtained for this research centre and payment is being given out of internal source of our University by the approval of the Law Department. It is resolved to send proposals to UGC or to funding Government agencies for grants in future.

The Syndicate also resolved that henceforth, the faculty of KSLU's Law School are to look into UGC website to get project funds to the University.
