


4. Has the Curriculum facilitated you in developing analytical and problem-solving skills?






9. Rate the opportunities the curriculum provides to excel in co curricular and extracurricular activities.






6. Rate your opinion on the relevancy/ sufficiency of the contents of the courses meeting the requirements of the profession 64 responses




8. Rate the scope of the curriculum in developing the following attributes - creativity, leadership, innovation, self motivation, workplace ethics, social responsibility 64 responses

9) Timely coverage of the syllabus is possible within the given teaching hours 24 responses










2. Ability to Contribute to the organisation requirements by the Alumnus 45 responses





# 3.Curriculum of the alumnus employee has taught relevant professional skills 45 responses




# 4. Analytical and problem solving skills of the Alumnus 45 responses





# 5. Flexibility to learn new techniques, adopt new ideas etc. 45 responses




# 6. Discipline (Work place behavior) of the Alumnus 45 responses





### Observation:
