5. Facilities such as Girls Hostels, Health Care are already provided and steps for providing facilities like college bus, ambulance etc. are in the process.
6. Measures such providing seed money, encouragement for publishing articles in reputed journal by giving appreciation award, duty leave with pay is given to participate in conferences Seminars etc.
7. Online facilities in the library are also made available for the use of students and faculties.



### PREAMBLE:

The Karnataka State Law University appointed Sri. Girishgouda G. Patil as Temporary Full Time Assistant Professor for the subject Management on 19/10/2010. Since then he has been serving in the University as Assistant Professor without break. He has already served more than Ten years in the University. When the University issued Notification (Notification No. KSLU/DPAR/2021-22/0700(A) dated:12/08/2021 and Re-notification No. KSLU/DPAR/2021-22 dated: 13/10/2021) for regular appointment of teaching faculty for various subjects including Management, Sri. Girishgouda G. Patil filed a Writ Petition in the High Court of Karnataka, Dharwad Bench, Dharwad (W.P. No. 103466 of 2021 (S-RES)) for which stay order was issued to the Notification and thereafter, it was quashed partially with respect to posts in History, Management and English subjects.

Sri. Girishgouda G. Patil claimed regularization of his service as per the Umadevi's judgment of the Hon'ble Supreme Court of India. The High Court in its judgment dated 07.06.2023 in W.P. No. 103466 of 2021 (S-RES) directed the University to consider the case of Sri. Girishgouda G. Patil based on the guidelines of Umadevi's case. The Syndicate in its meeting held on 27/08/2023 and Special Syndicate meeting on 21/09/2023 having gone through the High Court order directed the Vice Chancellor to implement the judgment. But the Registrar in the note sheet filing has observed that regularization cannot be made as he does not satisfy one out of four criteria laid down in Umadevi's judgment. This was discussed in Special Syndicate meeting and the Syndicate unanimously resolved and directed the Vice Chancellor to implement the above cited High Court order immediately.

Owing to Registrar's dissent note in the file noting to implement the order and reluctance to implement the Syndicate decision and, as the Vice Chancellor himself cannot directly issue any orders, he has authorized Assistant Registrar to issue regularization order. Therefore this order.

## ORDER


Sri. Girishgouda G. Patil is appointed as Assistant Professor in the subject Management to the Karnataka State Law University's Law School, Navanagar, Hubballi under Section 64 of Karnataka State Law University Act, 2009. His appointment is made against the vacant sanctioned post. He is on the pay band of Rs.57,700/- to Rs.1,82,400/- plus other admissible allowances under the prevailing UGC/State Government norms as amended from time to time.

**The appointment is subject to the following terms and conditions:**


1. That he / she will be on probation for a period of two years if his / her work during the period of probation is found satisfactory, he / she will be taken on permanent basis according to the Rules and service conditions of the University.
2. That he / she should be declared physically fit by the District Medical Officer. A certificate to this effect should be produced by the candidate within 15 days from the date of joining to his / her duties.
3. That he / she should execute a bond on a stamp paper of the value of Rs. 100/- (Rupees Hundred only) containing the terms and conditions furnished by this office at the time of joining to his / her duties.
4. That he / she is liable to be transferred to any place under the jurisdiction of Karnataka State Law University in the interest of the University service or liable to be transferred to any other Universities as per the Provisions of the KSLU Act 2009.
5. He / She may be entrusted with any other University / Law School related work in the interest of the University.
6. That in the event of his / her resignation for the Post under the university, he / she shall give at least three months' notice to the University and that in no case he / she relinquish his / her post unless he / she is allowed to do so in writing by the Registrar.
7. That he / she has to join the above appointment at his / her own cost and that no Travelling allowance / daily allowance will be paid for his / her journey performed for the purpose.
8. That he / she will not be allowed to apply for the outside post during the period of probation.

9. That he / she will be governed by the service conditions prescribed by the KSLU Act Statutes, UGC Guidelines and other provisions as amended or modified from time to time.
10. That he / she will not be entitled for pensioner benefits as per G.O. No. FD (SPL) 04 2005 dated 31-03-2006, and the New Pension System (NPS) shall be compulsory. Further at the time of joining to the service he / she shall submit an undertaking to effect that their service conditions regarding pension benefits are governed by the G. O. 




