NOTIFICATION

The Annual Convocation for the year 2011 will be conducted in the month of March 2012. In this Convocation, the PG Degree/ PG Diploma/ Certificate Course will be conferred on only those candidates who have passed their respective PG Degree/ PG Diploma/ Certificate Course Examinations held during the period of June 2011. The exact date and time of the convocation will be announced later.

Applications duly completed in all respects shall reach the Registrar (Evaluation), Karnataka State Law University, Hubli on or before 10.02.2012 without penal fees, and with penal fees of Rs. 100/- up to 20.02.2012. The applications received after the last date will not be entertained.

The Convocation application form can be downloaded from the K.S.L.U. website www.kslu.ac.in . Fill all the column with appropriate information needed, and send the application along with the applicable fee + application fee of Rs. 200/- in the form of DD drawn in favour of Finance Officer, K.S.L.U., Hubli, payable at Hubli or SBI challan in State Bank of India, K.S.L.U. Campus Branch, Navanagar, Hubli.

The candidate shall write their correct name as in the statement of marks at the qualifying examination both in English and Kannada. Attested copy of the statement of marks of all the semesters shall be enclosed with the application form.

The candidates qualified for the following Degree/ Diploma/Certificate Course during before June 2011 examination only, are eligible to apply for conferring the degree.

- a) P.G. Candidates.
- b) P.G. Diplma/ Certificate course
- c) Rank Holders shall enclose RANK CERTIFICATE along with convocation application form.

The candidates who have applied IN PERSON, and not attended the convocation will be required to pay an additional absentia charges of Rs. 500/- for P.G. course and Rs. 200/- for P.G. Diplma/ Certificate course then only Degree Certificates of such candidates will be sent by post.

The Degree Certificates of the candidates admitted as “IN ABSENTIA” will be sent by SPEED POST TO THEIR ADDRESS AFTER THE CONVOCATION IS OVER. Further, if there are any corrections in degree certificates, candidates shall submit the same for corrections within six months along with applicable fees from the date of receipt by post/ by hand.
