THE KARNATAKA STATE LAW UNIVERSITY'S STATUTE RELATING TO GRANT OF PERMANENT AFFILIATION TO COLLEGES OR INSTITUTIONS (FIRST AMENDMENT), 2016

In exercise of the powers conferred under section 47 read with section 5 (viii) and section 30 (xvi) of the Karnataka State Law University Act, 2009 (Karnataka Act 11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following statutes to amend the Statute relating to grant of Permanent Affiliation to Colleges or Institutions, namely:-

- 01. Title and commencement.- (1) This Statute may be called the Statute relating to grant of Permanent Affiliation to Colleges or Institutions, (First Amendment), 2016.
 - (2) It shall come into force from the date of assent of the Chancellor.
- **02.** Substitution of Clause 11: For clause 11 of the Statute relating to grant of Permanent Affiliation to Colleges or Institutions, (herein after referred to as the said statute), the following shall be substituted, namely:-
- "11. Pre-requisites of Temporary Affiliation:- No colleges shall be eligible for permanent affiliation in any Course / subject unless it has temporary affiliation for a continues period of five years in that Course/Subjects has fulfilled all the conditions of affiliation and attained the academic and administrative standards prescribed by the University from time to time. The eligible colleges shall submit the application for permanent affiliation/continuation of permanent affiliation on or before 30th April of the year."
- 3. Insertion of new clause 12-A:- After clause 12 of the said statute, the following shall be inserted, namely:-
 - "12-A. Proceedings to be submitted to the Government:- The Registrar shall submit the application and all proceedings if any, of the Academic Council and the Syndicate relating thereto, to the Government on or before 31st August of the year."
