Online applications for all above provisions are available in our university official web site www.kslu.ac.in, and all the concerned students are informed to fill the online application in your college compulsorily.

Further, all the Principles of all the affiliated Law Colleges are requested to direct concerned staff of your college to fill the online application form properly and take printout of online filled application form and duly signed by the concerned student is to be forwarded to the Registrar (Evaluation) Karnataka State Law University, Hubballi within the stipulated time mentioned bellow.

(College login ID and password of the college are same as provided earlier at the time of filling the examination application forms of December 2019).

Further, the Principals are informed to ensure that the fee amount collected from the students is to be credited to the University Account No.: 33339906448 (Branch Code 13201 and IFSC Code SBIN0013201) within 3 working days from the last date mentioned in the Notification.

Revaluation and Challenge valuation for the same Paper is not permitted.

The Principals of all affiliated Law colleges are hereby informed to bring the contents of this notification to the notice of all students of your college.

However, the colleges are requested to send the applications for Photo Copies immediately as and when applied by candidates rather than on last date. This will help KSLU to send photo copies as early as possible.

There is no provision in Examination Ordinance 2014 of Karnataka State Law University to refund the fees for Revaluation.

However, if there is increase of marks in Challenge Valuation, fees will be refunded as per the KSLU Examination Ordinances.

Note: Students who are applying for Challenge valuation shall provide the following details compulsorily.
