SPECIAL INSTRUCTIONS

1) The acceptance and registration of applications for the examinations is Provisional. Admission to examination is subject to students, fulfilling all other criteria prescribed including eligibility and attendance.


2) Students are required to remit Examination Form Fees (Rs.80/-) and Marks Card Fees (Rs.135/-) in addition to applicable Examination Fees.

3) In accordance with Notification issued by Commissioner of Backward Welfare Department of Karnataka State (Notification No.19/2012-13 dated 22.11.2012), among all the candidates coming under SC, ST, Category – I and only those coming under Categories 2(A), 2(B), 3(A), 3(B) **with annual income of not more than Rs.1,00,000/-** are exempted from paying Examination Fees. **(For further information you are informed to inquire with the concerned government department).** But these candidates must remit Examination Form Fees (Rs.80/-) and Marks Card Fees (Rs.135/-).

(i) All computerized applications for above mentioned course/semesters for Fresher's will be printed and sent by University Examinations office.

(ii) In addition to other requirements, students are required to fulfill at least 70% class attendance to be held eligible for admission to examination.

(iv) Application forms collected without penalty and with penalty should be sent in time as per notification.
