**THE KARNATAKA STATE LAW UNIVERSITY'S REGULATIONS  
GOVERNING THE THREE YEAR LL.B. DEGREE COURSE IN LAW  
(SECOND AMENDMENT), 2015**

The Academic Council of the Karnataka State Law University makes the following Regulations under Section 34(2) (iii) read with section 49 of the Karnataka State Law University Act, 2009.


Whereas the Karnataka State Law University's Regulations Governing the Three year LL.B. degree course in Law have come in to force from the date of assent of Chancellor i.e. 15<sup>th</sup> June 2009, and whereas it is considered necessary to amend the said regulations for the reasons hereinafter appearing, namely :-

**01. Title and commencement.- (1)** These Regulations may be called as "the Karnataka State Law University's Regulations Governing the Three Year LL.B., Degree course in Law (Second Amendment), 2015."

**(2)** They shall come into force on the date of their approval by the Chancellor:

**02. Amendment of Regulation 14** - In regulation 14 of the Karnataka State Law University's Regulations Governing three year LL.B., degree course in Law, after the second proviso, the following third proviso shall be inserted, namely :-

"(C) The Candidates who does not successfully complete their degree within 6years shall be given an extended period of 2 more consecutive attempts from the date of notification by the University."
