Online applications for all above provisions are available in our university official web site www.kslu.ac.in. and all the concerned students are informed to fill the online application in your college compulsorily.

Further, all the Principles of all the affiliated Law Colleges are requested to direct concerned staff of your college to fill the online application form properly and take printout of online filled application form and duly signed by the concerned student is to be forwarded to the Registrar (Evaluation) Karnataka State Law University, Hubballi with in the stipulated time mentioned bellow.

(College login ID and password of the college are same as provided earlier at the time of filling the examination application forms of June 2019).

However, the colleges are requested to send the applications for Photo Copies immediately as and when applied by candidates rather than on last date. This will help KSLU to send photo copies as early as possible.

There is no provision in Examination Ordinance 2014 of Karnataka State Law University to refund the fees for Revaluation.

However, if there is increase of marks in Challenge Valuation, fees will be refunded as per the KSLU Examination Ordinances.
