#### FOREWORD

It is my great privilege to write briefly the progress of Karnataka State Law University (KSLU) since 2009. KSLU with its headquarters at Navanagar, Hubballi was established in January 2009 under the Karnataka State Law University Act, 2009, (No.11 of 2009) as a Peoples' University. Its aspiration is to provide quality legal education, totally socially relevant and accessible to everyone. KSLU is a mono faculty university having 92 Law Colleges under its affiliation and having jurisdiction over the entire Karnataka State.

The University Library has acquired quality books and a good number of volumes of reports to meet the requirement of the faculty and students. The Library also has facilities of wifi and online data provision like West Law India, HeinOnline, Manupatra, Inflibnet and N-List for the students. The Library has been automated using an integrated Library Management System. Library holdings can be searched using the Online Public Access Catalogue.

The Examination wing is housed in a new exclusive building completed during 2013-15. It has adopted modern technologies for conducting examinations and valuation work, to keep confidentiality and to give fair and quick results to the students.

At present the University offers 3 year LL.B., 5 year B.A., LL.B., B.B.A., LL.B, Integrated and Honors Courses and LL.M. with specializations like Constitutional and Administrative Law, Corporate and Commercial Laws. Some PG Diploma and Certificate courses are also taught. Many Ph.D. students are engaged in doing research under the guidance of learned teachers of KSLU.

The University has established the College Development Council (CDC). It is headed by a Director, who is responsible in overseeing the day to day work and co-ordinates this, with all the affiliated colleges and requests the colleges to submit proposals for grant under various schemes of University Grants Commission (UGC). I am happy to indicate that many Colleges have already been enlisted under Section 2(f) and 12 B of UGC Act, 1956.

The NSS wing of KSLU has done tremendous work in the rural areas by arranging camps like Tree Plantation, Rain Water Harvesting, Blood Donation, Health Check up and Election Awareness in the nearby villages and helped the villagers in their day to day hurdles by giving legal aid service and advice. Similarly, the SC/ST Cell is doing wonderful work by providing necessary assistance in getting scholarship, studentship and the Government share of the OBC students' EBL charges etc. and genuinely looking after the welfare of the concerned students in co-ordination with the District Social Welfare Department. The Legal Cell is established to look after the cases filed against the University in the courts and to safeguard the interest of the University by using the services of panel advocates nominated by the University. A special mention should be made about the Directorate of Student Welfare of the University which is making every effort to conduct Seminars, Symposia, Moot Courts, Conferences, Debate, Elocution Competitions and Youth Festivals, extracurricular and extension activities etc. for the students during the academic year. There are two girls hostels and one boys hostel well maintained by KSLU.

The Right to Information (RTI) Cell has been established and a nodal officer is nominated for the Cell. The Cell is working effectively and many successful replies have been sent to RTI petitioners and some of the cases heard by the State RTI Commissioner are also attended to by the concerned University officials. Further, a Women's Grievance Redressal Cell is established in the University. The Cell is headed by a senior woman faculty. The Cell has been taking steps to watch and ward the well being of women staff and students in the campus. In addition, the Information Communication Technology Cell (ICT Cell) has been maintaining the University website and Computer Lab for the students. Over the years the Cell has been successfully conducting video conferences between the KSLU and Universities outside India and initiating the various Central Government projects like National Knowledge Network, for the mutual benefits of our students.

The Sports Section is headed by a Director of Physical Education and has been successfully conducting Inter-Collegiate Tournaments for Men and Women students of affiliated Law Colleges. The Sports Section is also looking after all the sports activities of the University as well as colleges. The students of the University have excelled not only in studies but also in sports.

The University has established its own Law School where many curricular and extracurricular activities are carried on. In the preceding One year the Law School has organized many Seminars, Conferences, Moot Courts, Workshops, Legal Aid and Clinical Programs in association with the Government Departments and NGOs of the country. I wish to make a special mention that UGC granted 12 B Status to the University. The University has been fortunate enough for having invited many talented scholars to enrich the already formidable pool of faculty, by delivering their scholarly talks.

The University has an Engineering Unit with Senior Engineers. The construction of the new Law School building is under progress. The developmental works for the boys training hostel are completed. The work of construction of University Guest House is in progress.

The Second Convocation of the University was held on 17<sup>th</sup> December 2015 which was presided over by the Hon'ble Minister for Law, Parliamentary Affairs and Higher Education, Governemnt of Kararnataka and Pro- Chancellor of the University, Sri T.B.Jayachandra, Former Chief Justice of India Hon'ble Mr. Justice H.L.Dattu, delivered the Convocation Address and three eminent legal luminaries have been awarded *Honoris Causa*. The recipients of the *Honoris Causa* were, Former Chief Justice of India, Hon'ble Mr. Justice H.L.Dattu, Hon'ble Mr. Justice N. Santosh Hegde.

Besides scholarships, the University has instituted other Endowment Prizes, Gold Medals, Cash Prizes and other Prizes for meritorious students. A few of them are instituted by some eminent law firms, companies and individuals which are given at the time of the Convocation.

The University is bringing out its Law Journals regularly since 2013. Four issues have been already released, which contain contributions by Former Chief Justices, Academicians and well known Scholars in the field of Law. The Student Law Review Vol. No. I and II have been released by the Student Editorial Board after scrutinizing it by a well known scholar in the field. Amruthavahini- the KSLU News letter No. 1 to 6 have been brought out during the years 2013 to 2016.

I express my deep appreciation and congratulations to the teaching and nonteaching staff of KSLU in helping us to provide a safe, peaceful and conducive environment for research and learning and for having dedicated themselves to this divine mission.

#### **1. INTRODUCTION**

The Government of Karnataka with a desire to make the study and research in law more systematic, society oriented and to inculcate among citizens a sense of concern for the law and the institutions of State, has established Karnataka State Law University through the Karnataka State Law University Act, 2009(No.11 of 2009). From the inception the University is striving to provide quality legal education which is professionally competent and socially relevant. It is endeavouring to promote the culture of law and justice in the institutions of State, Non-Government organizations and every individual through various programmes.

#### VISION

To transform Karnataka State into a legally conscious society, by providing quality legal education that is professionally competent and socially relevant so as to realize the Constitutional primordial goal of social, economic and political justice and secure human rights to every common man. Strive to promote the culture of law and justice in the institutions of State, Non-Government organizations and every individual by providing informal legal education training and legal service. Above all, to inculcate in everyone a spirit of high moral and human values.

#### MISSION

To produce law graduates and post graduates who will inspire and lead the community by putting 'service' before 'self'. Strive for excellence in professional legal education. Promote research activities to create basis for making law and legal institutions socially vibrant. Spread legal literacy and legal aid to the poor and needy with a view to take justice to the doorsteps of common man. Provide training to the members involved in the governance of the state, legislators and judiciary to sensitize them in matters of law and justice. Above all, work as a catalyst in inculcating a sense of faith among people of Karnataka in the institutions of law and justice to realize the goals of social welfare. The Karnataka State Law University is aiming to educate the populace on a realistic tone, close to the life, kindling socio-legal consciousness, enhancing marketability, unveiling employment openings by infusing better outlook and approach. A. LLB five year integrated course and one section of 60 students in B. B. A LLB Five Year integrated Degree Courses for a period of two years i.e. 2009-2010 to 2010-2011 subject to the condition that:-

- 1. Admission of the students be made strictly only on merit basis.
- University authority must submit the list of law colleges comes under its jurisdiction.
- Before starting the admission process of the students the institution should try to get the approval of statute and ordinance from the State Govt."

A proposal has already been submitted to the Government under this Office letter No.KSLU/ADM/CR-20/2014-15/2844, dated:20-02-2015to establish one Multi Disciplinary Research Centre comprising of five sub-centres namely as under:

- 1. Centre for Studies and Research in a Democracy and Constitutional Government
- 2. Centre for Studies and Research in Issues in Land Resource Management and Law
- 3. Centre for Studies and Research in Issues in Water Resource Management and Law
- 4. Centre for Studies for Women and Law
- 5. Centre for Studies in Mining, Energy, and Environment: Law and policy.

Likewise, necessary proposals have also been submitted to the UGC, under this office letters No: KSLU/Adm/CR-19(B)/2014-15/, dated:13-04-2015 and No:KSLU/Adm/R.C./2015-16/, dated:11-08-2015, for seeking both administrative as well as financial approvals. Necessary sanctions are awaited.
