1. Applications and all other details will have to be downloaded from the University website (www.kslu.karnataka.gov.in) and no printed application form will be supplied by the University.
2. Qualification, pay scales and other eligibility conditions are as per UGC norms as revised from time to time.
3. The candidates who wish to apply for more than one post should submit separate application form for each post along with prescribed fee.
4. The selected candidates must be prepared to work in any post graduate centre coming under the jurisdiction of Karnataka State Law University, Hubballi.
5. No. TA/DA will be paid to the candidates attending the interview.
6. Late and incomplete applications will be rejected.
7. Any type of direct or indirect canvassing for the post will disqualify the candidate.
8. Duly filled in application should reach the office of the Registrar, Karnataka State Law University, Hubballi on or before **27-9-2021**.
9. The copies of publications, testimonials, certificates, caste certificates, marks cards, and Abstract Form should be enclosed to all eight sets of application.
10. Those who are employed should send their application through proper channel. However, an advance copy may be sent directly.
11. The envelopes containing application should be super scribed as “Application for the post of _____”.
12. The Abstract Form and the Application Form along with all relevant documents should be sent in bound form.
13. Academic Record Scores as mentioned in UGC Regulations 2018 Table 3 - A should be calculated as per the instructions and enclosed (Applicable only for the posts of Assistant Professors).
14. In case of copies of publications enclosed to the application the pages containing ISSN/ISBN number as well as authors name should be necessarily included.
15. The University has got the right to reduce the number of posts or alter or re-allocate or cancel posts as per its requirement.
16. The University reserves the right to fill or not to fill the posts advertised.
17. The candidate selected will be appointed on probation for a period of 2 years and the probationary period may be extended if the University so desires.

18. Intimation about interview will be sent through e-mail as well as written communication. Communication in any one form reaching the candidates shall be considered as proper communication.
19. The University will not be responsible for any postal delay in any correspondence with the candidates/applicants.
20. Any change in address of correspondence/mobile/telephone number and e-mail address shall be communicated to the University in writing.
