- 10. Those who are employed should send their application through proper channel. However, an advance copy may be sent directly.

- 13. Academic Record Scores as mentioned in UGC Regulations 2018 Table 3 A should be calculated as per the instructions and enclosed (Applicable only for the posts of Assistant Professors).
- 14. In case of copies of publications enclosed to the application the pages containing ISSN/ISBN number as well as authors name should be necessarily included.

- 17. The candidate selected will be appointed on probation for a period of 2 years and the probationary period may be extended if the University so desires.
