<p>Rule: 15.</p> <p>a) No students shall be promoted to the next year for the course unless he/she has passed in a minimum of two subjects in either semester or one subject in each semester</p> <p>b) Students are required to successfully complete the entire course within ten years from the admission to the course.</p> <p>c) The candidates who have taken admission to 5 year B.A.,LL.B. Course and have not successfully completed their degree within 10 years from the date of their admission shall be given an extension of one year comprising of two consecutive attempts to complete their degree from the date of Notification</p>	<p>Rule: 15. (d) One more last opportunity as Golden Chance shall be given to the students to complete their degree to those students who have taken admission for the academic years 2009-10, 2010-11 and who have not successfully completed their degree.</p>	<p>In view of the representations received from the students to the University for the extension of duration for completing the Course due to Covid-19 Pandemic situation as the students were unable to effectively use the extended last opportunity to complete their Course as per Fifth Amendment 2020.</p>
