Proceedings of the Syndicate Sub-Committee constituted for preparing the affiliated law college Principals' Seniority list for the year 2021-22.

A meeting of Syndicate Sub-Committee constituted for preparing the affiliated law college Principals' Seniority list was convened on 15th October, 2022 at 11.00 a.m. held at Conference hall of the University.

Convener

At the outset, Convener welcomed the Chairperson and member of the Committee. Thereafter, the UGC Regulations from 1998 to 2018 pertaining to essential conditions for appointment of Principals of the Colleges were examined. Even the University Circular No. KSLÚ/Acadm/ Prin.Seni/2021-22/0772 dated 03.08.2022 was taken note off.

By virtue of above cited Circular, the University had directed the Principals of all the affiliated Law Colleges to furnish the details as sought for under it. In response to the same, out of 109 affiliated law colleges only 77 affiliated law colleges have sent the details of the Principals.

The relevant norms relied upon by the Committee for the purpose of preparing seniority list (tentative) of the Principals of the affiliated law colleges are as under:

Clause 20 of Schedule-III of BCI's Legal Education Rules, 2008 stipulates that the Principal of the Centre for Legal Education shall be of a Master's Degree or as prescribed by UGC.

As UGC is a Higher Education Regulatory Body and norms laid down by it govern the appointment and promotion of teachers in educational institutions, its norms are relevant for the purpose of determination of seniority of the Principals of the affiliated law colleges. The relevant UGC norms are as under:

Regulation 4.2.1 of the UGC Notification on Revision of Pay Scales, Minimum Qualification for Appointments of Teachers in Universities, Colleges and Other Measures for the Maintenance of Standards, 1998 stipulates essential qualification for the post of Principals as under:

"4.2.1 PRINCIPAL

- 1. A Master's Degree with at least 55% of the marks or its equivalent grade 'B' in the 7 point scale...
- 2. Ph.D. or Equivalent Qualification.
- 3. Total experience of 15 years of teaching/research in Universities/Colleges and Other institutions of Higher Education."

Similarly, Regulation 1.1.0 of UGC Regulations on Minimum Qualifications for Appointment and Career Advancement of Lecturer, Readers and Professors in the Universities and Colleges, 2000 stipulates the requirements as enumerated above.

Further, Regulation 4.2.0 of the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2010 stipulates essential qualification for the post of Principals as under:

"4.2.0. PRINCIPAL

i. A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) by a recognized University.

- ii. A Ph.D. Degree in concerned/allied/relevant discipline(s) in the institution concerned with evidence of published work and research guidance.
- iii. Associate Professor/Professor with a total experience of fifteen years of teaching/research/administration in Universities, Colleges and other institutions of higher education..."

Even the Regulation 4.1 (V)(A) of UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Other Measures for the Maintenance of Standards in Higher Education, 2018 stipulates the requirements as specified above.

After examining the norms set out above and the requirements specified in the University Circular dated 03.08.2022, the Committee unanimously resolved to strictly follow the requirements stipulated under above cited UGC Regulations as well the University Circular for the purpose of determination of seniority of the Principals of the affiliated law colleges.

With respect those teachers who have been appointed as Principals subsequent to the year 2009 the Committee resolved to adopt the following criteria for determination of seniority:

- 1. 15 years of teaching experience as fulltime lecturer/Assistant Professor (the years of experience is reckoned from the date of appointment as fulltime lecturer/Assistant Professor in the institution).
- 2. Possessing of Ph.D. degree.
- 3. Appointment as fulltime Principal.

With respect to those teachers who have been appointed as Principals before or in the year 2009 the Committee resolved to adopt the following criteria for determination of seniority:

1. 15 years of teaching experience as fulltime lecturer/Assistant Professor (the years of experience is reckoned from the date of appointment as fulltime lecturer/Assistant Professor in the institution).

- 2. Ph. D. degree was considered desirable but not mandatory.
- 3. Letter of approval confirming the appointment to Principal's post issued by the University concerned or letter of appointment/nomination by virtue of which he/she is nominated to the various statutory bodies of the University concerned.
- 4. Appointment as fulltime Principal.

Accordingly the Committee scrutinized the applications sent by the affiliated law colleges and prepared tentative list of seniority of Principals of affiliated law colleges. After the detailed discussion, the Committee resolved to approve the said tentative list of seniority of Principals of affiliated law colleges. The tentative seniority list is enclosed as **Annexure A**. The same was submitted to the University for further course of action.

Even the list of the Principals of affiliated law colleges who have not been considered for the purpose of seniority is also enclosed as **Annexure B**. The Committee unanimously agreed upon the following reasons for not considering such Principals for the purpose of seniority:

- 1. Those who do not possess the essential qualifications stipulated under the UGC Regulations thus do not fit into the criteria as enumerated above.
- 2. Those who are serving as In-charge Principals.
- 3. The Principal of Autonomous Law College by virtue of Section 62 of Karnataka State Law University Act, 2009.
- 4. Those Principals who are pursuing Ph. D. degree.

The list of the affiliated law colleges which have not submitted the details of the Principals is enclosed as **Annexure C**.

It was resolved to circulate the above stated lists to all the affiliated law colleges and also post the same on the University website.

It was resolved to provide a period of 10 working days to the Principals of affiliated law colleges to submit the objections, if any, with respect to the tentative seniority list.

It was resolved that, if objections are received then the Committee has to duly consider such objections and if found appropriate, then it may revise the tentative seniority list suitably.

It was resolved that, if objections are received subsequent to the expiry of 10 working days then such objections shall not be considered.

It was resolved that, if no objections are submitted then the University may consider this tentative list as final list and accordingly proceed with the notification of the same.

The meeting was adjourned with thanking the Chair.
