

**THE KARNATAKA STATE LAW UNIVERSITY ORDINANCE GOVERNING THE
IMMIGRATION OF STUDENTS FROM OTHER UNIVERSITY TO KARNATAKA
STATE LAW UNIVERSITY, HUBLI-2012**

The Syndicate of the Karnataka State Law University, Hubli makes the following Ordinance under Section 30 (i) read with Sections 48 (a), (b), (c) of the Karnataka State Law University Act, 2009. It is considered necessary to provide for Immigration of students from other Universities to KSLU, Hubli. Hence this Ordinance.

1. TITLE AND COMMENCEMENT

1. The Ordinance may be called "Ordinance Governing Mid-course Immigration of students of Law programme from other University to Karnataka State Law University, Hubli-2012"
2. It shall come into force from the date of assent of the Chancellor.

2. IMMIGRATION OF STUDENTS FROM OTHER UNIVERSITY TO KSLU

1. An Immigration of student from other Universities to the college affiliated to the Karnataka State Law University, Hubli may be allowed under the following conditions, namely:
 - i. Student must have been enrolled as regular student in the Dept. of Law/Colleges affiliated to any University established under UGC Act and recognized by Bar Council of India, New Delhi.
 - ii. The Law course for which a student has been enrolled in any other University must also be a course offered by KSLU and the syllabus of both the courses must be similar. The student must have passed in all the subjects/papers, already studied in other University.
 - iii. Student shall make an application for Immigration in the form prescribed along with enclosures to the Principal of any affiliated Law College of University, where the student is seeking admission on immigration.
2. On receipt of the application, the Principal of the college to whom the application is submitted by the student shall verify the particulars in the application and record the certificate in the form prescribed. If found correct the applicant shall be asked to draw a D.D. of Rs. 500/- towards processing fee and forward the application with the following documents:
 - i. The duly filled application form in the form prescribed.
 - ii. Syllabus of the Law course being studied at other University.

- iii. The N.O.C. from the transferring Law College.
- iv. The attested copies of previous semester/s all marks cards of Law course.
- v. The D.D. of Rs. 500/- towards processing fee drawn in favour of Finance Officer, KSLU, payable at Hubli.
- vi. NOC of the transferee Law College.

3. **The Registrar** On receipt of the application of immigration from the Principal of the affiliated college to which the student had sought immigration, may issue permission letter for the admission on immigration after approval by Hon'ble Vice-Chancellor, to the student and the Principal of the transferee Law College (to which the student had sought Immigration) or reject the application, and his order thereon shall be final.

The approval of immigration of admission shall be given on below conditions :

- i. The applicant shall have passed all the subjects of previous semesters during the studies at earlier University and had produced a migration certificate from the University from which he had studied earlier.
- ii. The applicant has to study on his own and pass the examinations of the subjects, not studied during the earlier studies at other University, but which were prescribed by KSLU for the said semesters.
- iii. Further he will be given only two chances for passing such subjects.
- iv. He is not eligible for award/claim of any ranks/medals likewise out of his studies at KSLU, Hubli.

4. On approval of immigration of admission the students shall obtain the Migration Certificate from the concerned University and submit the same to KSLU.

3. REPEAL AND SAVINGS

- a. Any ordinance existing herewith before relating to Immigration of students from one college to another college within the University stands repealed.
- b. Any action, decision or direction taken or directed by the University under any Ordinance in force at any time earlier than this Ordinance coming in force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Ordinance.


