



# 4. Parent Feedback on Curriculum & Syllabus Evaluation



# Q. No. 1 Do you think by studying the existing syllabus your child/ ward is acquiring professional skills?









Q. No. 3 How do you think the course helps in your child/wards overall development?

### **Observations:**

The following are the observations made from the feedbacks given-
