




Amendments to Regulations Governing 3 Year LL.B. Degree Programme, 2020

<p>13. No student shall be permitted to appear for the end-of-semester examination in a given course unless he/she has, to the satisfaction of the course teacher, fulfilled the course requirements and has put in not less than 70% attendance in the course concerned.</p> <p>Provided that a student who has attended not less than 65% of classes in each of the subjects prescribed may be permitted to keep the term for reasons to be recorded in writing and to the satisfaction of the Principal of the College or the Dean of the Faculty as the case may be.</p>	<p>13. No student shall be permitted to appear for the end-of-semester examination unless in a given course he/she has fulfilled the course requirements and has kept the term by putting in not less than 70% attendance in the course concerned. A student shall keep the term by filing the examination application form with necessary fees.</p> <p>Provided that a student who has attended not less than 65% of classes in each of the subjects prescribed may be permitted to keep the term for reasons to be recorded in writing and to the satisfaction of the Principal of the College or the Dean of the Faculty as the case may be.</p>	<p>To infuse clarity in the existing regulations.</p>
<p>14. (a). Every student shall be promoted to next higher classes irrespective of the fact that he has failed in any of the papers prescribed for the study.</p> <p>(b). Students are required to successfully complete the entire course within six years from admission to the course.</p>	<p>14. (a). Every student shall be promoted to next higher classes irrespective of the fact that he has failed in any of the papers prescribed for the study.</p> <p>(b). Students are required to successfully complete the entire course within five years (three years of normal duration plus two years of extended duration) from admission to the course.</p> <p>(c) The candidates who does not complete their degree within five years shall be given an extended period of one more year in exceptional circumstances mentioned herein after.</p> <p>When the candidate is unable to appear for the examinations during the extended period of two years-</p>	<p>To bring the regulations in conformity with the UGC guidelines as directed vide letter No. D.O.No.F.12-1/2015 (CPP-II) dated: 15th October 2015.</p>

	<p>i. Due to health reasons to be certified by a qualified medical practitioner.</p> <p>ii. Due to supervening disability to be certified by a qualified medical practitioner.</p> <p>iii. Due to representing the Country/ State/ University in any sports or co-curricular competitions.</p> <p>Provided the candidate has reported the inability to appear for the examination to the Registrar through the Principal of the respective college within one month of the date of examination which he/she is unable to attend or the term he /she is unable to keep.</p> <p>Provided further that the candidate who has represented the Country/State/University in any sports or co-curricular competitions as done so with the prior permission of the University obtained by applying through the Principal of the College.</p> <p>(d). A student who has kept the terms of any semester shall be allowed to go to the next semester.</p> <p>(e). A student who fails to keep the terms in even semester of any year shall keep the terms of the even semester along with the students of subsequent batches.</p> <p>(f). A student who fails to keep the terms in odd semester of any year shall take the readmission to the same year along with the students of subsequent batches.</p>
