HOSTEL REGULATIONS

I. General

Regulations for the Maintenance of Discipline and Conduct

- 1. Every student of the University shall conform to the ordinary rules of good conduct and respect the authorities of the constituted bodies of the University.
- 2. Students shall do everything possible to protect and make proper use of the University property. Any student who attempts to deface or destroy the University or other public property shall be liable for punishment.
- 3. Proper decorum shall be maintained by all the students in the class rooms, hostels, Legal Aid/NSS Programmes, educational and sports tours, transport vehicle and on and off the University/College Campus.
- 4. No students shall disturb the normal work of the University by disorderly conduct, boisterous behaviour and unauthorised assembly.
- 5. Ragging and hazing in any form in the University premises is strictly prohibited.
- 6. Possession or consumption of alcoholic drinks or drunkenness or drug addiction or gambling on the campus is strictly prohibited.
- 7. Celebration of festivals on days other than authorised ones and unruly behaviour on such occasions will be considered as an act of indiscipline.
- 8. Violation of any of the regulations is an act of indiscipline and it shall be brought to the notice of the Director Law School KSLU.
- 9. Director Law School KSLU shall enquire into the act of indiscipline of the student/s and shall take immediate action such as administering a warning, imposing fine, expulsion from hostel and suspension from attending the classes for a period not exceeding one month.
- 10. Further, in serious cases of indiscipline, the disciplinary proceedings may be initiated through the Disciplinary Committee comprising the Director of the Law School as Chairman, the Director of Students Welfare, three senior faculty members of the college and Warden as members which can recommend to the Registrar of the University for punishment in the form of expulsion from the college for a semester/year.
- 11. The recipients of the student concession or other benefit from the University or form other institution will loose these concession and benefits, if they are found to be involved in any of the acts of indiscipline, by an order of the University.
- 12. The decision of the Vice-Chancellor under these regulations shall be final.

II. Admission

- 1. Students who have taken admission to the KSLU Law School are eligible to apply for admission to the Hostels. Admission to students will be only to the extent of availability of accommodation in the hostels, preference being given first to regular students. Those students who have already completed their normal duration of the degree to which they were admitted are not eligible for admission to Hostels. The Hostel Supervisory Committee will have the right to refuse admission for those whose conduct in found to be unsatisfactory during their previous period of residence in the hostels.
- 2. Application forms and copies of the Hostel Regulations may be obtained in person from the office of the Law School KSLU.
- 3. Students shall submit their application for admission to the hostels in the prescribed form well in advanced and selected students can join the hostels after paying the prescribed fees.
- 4. The Director of Students Welfare/Warden shall consider the following guidelines while selecting students for admission to hostels at the commencement of the academic year.

General criteria for Hostels Admission:

- a. Reservation policy issued by the government from time to time shall be followed strictly.
- b. Students from mofussil areas.
- c. On the basis of Merit/Distance.
- 5. Allotment of rooms shall be at the discretion of the Chief Warden. Allotment or re allotment of rooms to a student shall be made only after the payment of all the prescribed fees.
- 6. All the students admitted to the hostels shall necessarily be the boarders in the hostels and they constitute the residents.

III. Hostels Life

- 1. The Chief Warden / Warden shall assign two or more residents to a room depending upon availability of accommodation in the hostel.
- 2. No student shall change the room, articles and furniture etc. Allotted to him/her without prior approval of the Chief Warden/ Warden.
- 3. 1) The residents shall keep their rooms clean, neat and tidy. The students are responsible jointly and as well as individually for the article / permanent fittings in the rooms. The residents shall not disfigure the walls of rooms, corridors by writing or by indiscriminate driving of nails or by fixing posters, photographs, etc.
- 2) Hostels rooms shall be opened by the occupants for inspection by the Director KSLU's Law School, Director Student Welfare Warden and other officers of the University

whenever required. The above University officials can arrange to open the rooms under special circumstances with due orders.

- 4. All residents shall provide themselves with electric bulbs required for their rooms. Occupants of rooms shall not waste electricity and shall invariably put off all the lights, fans etc. while retiring or leaving the rooms. No radio set, TV, heaters and/or other electric gadgets shall be used in the rooms.
- 5. Residents shall not damage or tamper the permanent fixtures/hostels property. Residents are liable for fine or to make good of the damaged articles if found responsible by an enquiry. Common passages, corridors and toilets shall be provided with suitable fixtures and electrical materials whenever required, by the Hostels authorities.
- 6. Students are expected to make proper use of hostels amenities like computer room, TV Hall reading room, sports facility, bathrooms, toilets, water closets, wash basins etc. They shall park their vehicle in the parking area.
- 7. Residents shall be solely responsible for the safe custody of their belongings and shall take adequate precautions towards this end.
- 8. Residents shall not be permitted to keep or use fire arms, missiles, narcotics, alcohols or other intoxicants either in the rooms or in the hostels premises. Drinking alcohol and consumption of intoxicating drugs, gutakha, smoking etc. shall be strictly prohibited.
- 9. Any form of gambling or participation in games of chance or playing of music inside rooms or causing annoyance to others in the hostels is strictly prohibited. No student shall himself/ herself act or initiate others to act in a manner calculated to cause annoyance to others in the hostel.
- 10. Persons other than Hostel inmates shall not enter the hostel without the approval of the Warden.
- 11. Guests of residents are not permitted to stay in the student's room overnight.
- 12. No students shall remain outside the hostel after 8 PM on working days and 8 PM on holidays without the prior permission of the Warden. The girl student in any of the Ladies Hostels of the University shall not remain outside the hostels after 8 PM on any day without prior permission of the concerned warden. Girl students may visit their already declared guardians duration day time on holidays after making necessary entries in the movement register. If he / she does not obey these rules and continues the same for more than three times, he/she will be liable for punishment to the extent of expulsion from the hostels/college.
- 13. Residents are required to treat all hostel employees with courtesy and with due respects. Students (s) behaving indifferently with hostel employees are dealt with disciplinary measures on receipt of complaints by the Warden.
