**THE STATUTE RELATING TO CONSTITUTION OF LOCAL AND  
SURPRISE INSPECTION COMMITTEES AND ALLOWANCES  
PAYABLE TO THE CHAIRPERSON, MEMBER AND CONVENER OF  
SUCH COMMITTEES, 2021**

In exercise of the powers conferred under section 30 (i) read with section 46 of the Karnataka State Law University Act, 2009 (Karnataka Act No. 11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Statute namely;

**1. Title, Application and Commencement -**

- a) This Statute shall be called as “The Statute Relating to Constitution of Local and Surprise Inspection Committees and Allowances payable to the Chairperson, Member and Convener of the such Committees, 2021”.
- b) This Statute shall come into force from the date of the assent of the Chancellor.
- c) This Statute shall apply to the Local and Surprise Inspection Committees constituted by the University.

**2. Constitution of Local and Surprise Inspection Committee –**

- a) The University shall constitute a Committee called Local or/and Surprise Inspection Committee consisting of such members as it may deem fit.

**Explanation:** The Members may include Syndicate Members, Academic Council Members or/and Principals of Affiliated Law College of the University or/and teaching staff of affiliated law Colleges of the University and KSLU’s Law School.

- b) The Committee so constituted shall conduct the inspection of affiliated / Autonomous Law Colleges in accordance with Statutes and guidelines issued by the University from time to time.
- c) After the inspection, the Committee shall submit the report to the University in stipulated period.

**3. Sitting fees -**

- a) The sitting fees as shown in the schedule shall be payable to the Chairperson, Member and Convener of Local and Surprise Inspection Committee.

- b) The Syndicate shall have the power of enhancing the sitting fees payable to the Chairperson, Member and Convener of Local and Surprise Inspection Committee from time to time.

**4. Travelling Allowance -**

- a) The traveling allowance payable shall be the actual Train fare, that is 2<sup>nd</sup> AC charges or/and 1<sup>st</sup> class AC bus fare or Mileage allowance for road journey in hired or borrowed conveyance at the rate as fixed by the Syndicate from time to time on the basis of prevailing market rates.
- b) If any member of the Committee uses his/her private / personal vehicle then the mileage allowance as approved under clause (a) may be payable to the respective member.

**5. Daily Allowance -**

- a) The Daily allowance as mentioned in the schedule annexed to this Statute shall be payable to the Chairperson, Member and Convener of Local and Surprise Inspection Committee.
- b) The Syndicate shall have the power of enhancing the rate of daily allowance payable to the Chairperson, Member and Convener of Local and Surprise Inspection Committee from time to time.

**6. Repeal and Savings Clause -**

- a) Any Statute existing hereinbefore relating to the Constitution of Local and Surprise Inspection Committee and allowances payable to the Chairperson, Member and Convener of such Committee stands repealed.
- b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Statute.
