**THE STATUTE RELATING TO PROGRAMME DEPOSIT TO BE GIVEN
BY THE AFFILIATED /AUTONOMOUS LAW COLLEGES FOR THE
DEGREE PROGRAMME IN LAW, 2021**

In exercise of the powers conferred under section 30 (i) read with section 46 of the Karnataka State Law University Act 2009, (Karnataka Act No. 11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Statute namely;

1. Title, Application and Commencement –

- a) This Statute may be called as “The Statute Relating to Programme Deposit to be given by the Affiliated /Autonomous Law Colleges for the Degree Programme in Law, 2021”.
- b) This Statute shall come into force from the date of the assent of the Chancellor.
- c) It shall apply to the Affiliated / Autonomous Law Colleges (hereinafter referred to as Law College) coming under the jurisdiction of Karnataka State Law University, Hubballi.

2. Programme Deposit –

- a) Any new Law College which obtains affiliation from the University shall deposit Rs. 3,00,000/- (Three Lakh Rupees only) with the University for starting each Programme, other than P.G. Diploma and Certificate Programmes, specified in the schedule annexed to this Statute. The said amount has to be deposited with the University before starting such Programme.
- b) All the existing Law Colleges shall also deposit Rs. 3,00,000/- (Three Lakh Rupees only) for each Programme specified in the schedule annexed to this Statute, with the University.
- c) The Syndicate shall have the power of enhancing the deposit amount from to time.
- d) The Syndicate shall have the power to insert any existing or new course to the Schedule.
- e) The deposit so collected shall be refundable deposit.

3. Utilization /return of Programme Deposit –

- a) The deposit shall be dealt with by the University as per the decision of the Syndicate taken from time to time.
- b) On closure of the college or programme or in any other exigencies, the Law College shall submit an application to the University for the return of Deposit.
- c) On receipt of the application, the Registrar shall examine as to the dues of the said Law College.
- d) After deducting the administrative expenses, dues (if any) and any other relevant expenses from the Deposit, the Registrar shall order for the disbursement of balance amount of the Deposit in favour of the Law College concerned.
- e) The interest accruing to such Deposit shall be credited to the account of the University. It shall not be refundable to the Law Colleges.

4. Repeal and Savings Clause -

- a) Any Statute existing hereinbefore relating to the Programme Deposit to be given by the Law Colleges for the Degree Programme in Law stands repealed.
- b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid and remain in force not withstanding anything contained in this Statute.
