NOTIFICATION

In exercise of the powers conferred under Sec. 47 read with Sec. of the Karnataka State law University Act, 2009 (Karnataka Act No: 11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Statute, namely:-

STATUTE GOVERNING THE POWERS AND FUNCTIONS OF THE REGISTRAR

[Under Section 30 (i) and (xiv) of the Karnataka State Law University Act, 2009.]

1. TITLE AND COMMENCEMENT

- a) This Statute shall be called "Statute Relating to the Powers and Functions of the Registrar."
- b) This Statute shall come into force from the date of assent of the Chancellor.

2. POWERS OF THE REGISTRAR

The Registrar shall exercise the following powers:

- a) He shall exercise all the powers as an executive officer of the University assigned to him under the Karnataka State Law University Act 2009.
- b) He shall also exercise powers delegated to him by the Vice-Chancellor and various Authorities of the University.
- c) He shall supervise all the Sections and Departments of the University except Examination Section and Finance Section.
- d) He shall execute the decisions of the IUB, the Syndicate, the Academic Council, the Planning, Monitoring and Evaluation Board and other Authorities of the University,
- e) He is empowered to maintain discipline in the hostels and other residences on the campus.
- f) He shall exercise all such powers as required for maintaining discipline among the employees of the University.
- g) He shall exercise all such powers that are required to protect and maintain the University property in consultation with the Vice Chancellor and other appropriate Authorities of the University.
- h) He shall exercise all such powers that are required to maintain legal proceedings on behalf of the University to protect the interest of the University.
- i) He shall be empowered to take all such-actions that are necessary to maintain the standards in the law colleges affiliated to the University as per norms stipulated by the University and the Authorities of the University.
- He shall exercise such other powers as prescribed by the KSLU Act, Statutes, Ordinances and Regulations.

3. FUNCTIONS OF THE REGISTRAR:

Subject to the provisions of the Karnataka State Law University Act 2009, the Registrar shall perform the following functions:

 a) He shall be responsible for maintaining all the records of the university including seal of the university.

- b) He shall administer the matters relating to the purchases of furniture, equipments, stationeries, consumables and such other articles as may be required for the smooth functioning of the university.
- c) He shall take all necessary steps to maintain the University property.
- d) He shall ensure regular attendance and work of the non teaching employees of the University.
- e) He shall ensure the smooth functioning of the Hostels, Guest Houses, Health Centre, Common Catering Facility, Library, Sports and Cultural activities and such other central facilities.
- f) He shall ensure the maintenance of buildings, garden and other infrastructure facilities on the entire campus of the university.
- g) He shall exercise all such other functions as prescribed by the KSLU Act and the Statutes, Ordinances and Regulations made there under.

4. REPEAL AND SAVINGS CLAUSE

- (a) Any Statute existing hereinbefore relating to the Powers and Functions of the Registrar stands repealed.
- (b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Statute.
