

## **STATUTE**

### **STATUTE RELATING TO ESTABLISHMENT OF FELLOWSHIPS, SCHOLARSHIPS, GOLD MEDALS, ETC**

[Under Section 30(xxx) and 46 (13) of the *Karnataka State Law University Act, 2009*]

#### **1. TITLE AND COMMENCEMENT**

a) This Statute may be called as “the Statute Relating to Establishment of Fellowships, Scholarships, Gold Medals, etc.”

(b) It shall come into force from the date of the assent of the Chancellor.

#### **2. INSTITUTION OF FELLOWSHIPS, ETC**

(a) The syndicate may, in consultation with the authorities of the University as it deems fit to institute Fellowships, Traveling Fellowships, Scholarships, Studentships, Stipends, Medals and Prizes.

(b) No Scholarship, Prize or Medal shall be instituted and awarded on the basis of religion, caste or community or institution:

#### **3. AMOUNT FOR INSTITUTION OF FELLOWSHIPS, ETC**

The minimum amount to be donated by the donors for instituting an endowment in the University shall be at the following rates namely:

(i) for arranging an Endowment Lecture	Rs. 5,00,000/-

Any person within the country can be invited, (The T.A. and D.A., Printing and lecturing will be met from the interest).

(ii) for awarding a Scholarship	Rs. 1,00,000/-
---------------------------------	----------------

(iii) for awarding a Gold Medal.	Rs. 3,00,000/-

(iv) for awarding a Cash Prize.	Rs. 1,00,000/-

(v) for creation of a fellowship	Rs. 3,00,000/-

(vi) Free Studentship including half free studentship	Rs. 3,00,000/-

#### **4. PROCEDURE**

(a) A proposal for the institution of Fellowships, Endowment Lectures, Studentships, Stipends, Medals and Prizes by an individual or body shall be made to the Registrar in writing accompanied by a Cheque or Bank Draft in favor of the Registrar or a Bank Challan for having credited the amount to the Karnataka State Law University funds

together with a copy of the terms of award proposed by the donors.

- (b) When a proposal for instituting a scholarship, medal, prize is received, it shall be placed before the Academic Council which shall recommend the terms of award. The proposal along with the recommendation of the Academic Council thereon shall be placed before the Syndicate for approval.
- (c) The Syndicate may accept such a proposal with such modification as it may deem necessary with regard to the conditions made in the proposal.
- (d) The donor shall enter into agreement with the University regarding the conditions of award as approved by the Syndicate.
- (e) The University shall invest the fund endowed in Government securities as it may deem fit. and award scholarships, medals, prizes, etc., out of the interest accruing thereon. If in any year no medal or prize is awarded, the interest shall be added to the corpus of the endowment. In case the donor desires that the first medal or prize be awarded at a Convocation held before expiry of one year from the date of acceptance of the endowment, he may pay to the University separately in cash, the actual cost of such medal or prize.
- (f) The Syndicate shall have power to award a cash prize whenever the interest out of the endowment is not sufficient for the award of a Gold Medal. If an candidate is prepared to meet the extra amount it may be considered for the award of the gold medal.
- (g) The medals and prizes shall ordinarily be awarded at the Annual Convocation of the University.
- (h) The existing Fellowships, Traveling Fellowships, Scholarships, Stipends, Medals and Prizes shall continue as if they have been instituted under the Karnataka State Law University Act 2009.

## **5. FREE STUDENTSHIPS**

Provision shall be made for awarding free studentships (which may include half-free studentships) in a University institution, the percentage being calculated on the strength of University and constituent colleges exclusive of the number of holders of Government Scholarships. Such free-studentships and half-free studentships shall be awarded by the respective College Committees appointed by the KSLU for the purpose.

## 6. REPEAL AND SAVINGS CLAUSE


(a) Any Statute existing hereinbefore relating to Establishment of Fellowships, Scholarships, Gold Medals, Etc stands repealed.

(b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Statute.
