

## **STATUTE GOVERNING POWERS AND FUNCTIONS OF LIBRARY COMMITTEE**

Statute relating to the Powers and Functions of Library Committee,  
under section 43 of Karnataka State Law University Act 2009.

### **1. Title and Commencement:**

- a) This Statute may be called as “the Statute relating to Powers and Functions of the Library Committee, 2010”.
- b) It shall come into force from the date of assent of the Chancellor.

### **2. Constitution of Committee:**

**Library Committee shall consist of the following members namely:-**

- i) The Vice-Chancellor as the Ex-officio Chairman.
- ii) Two Syndicate members nominated by the Syndicate.
- iii) One Academic Council Member nominated by the Syndicate.
- iv) One female member nominated by the Syndicate among Syndicate or Academic Council.
- v) Director of KSLU's Law School.
- vi) Librarian as the Ex-Officio Member Secretary.

### **3. Tenure:**

The tenure of office of the members nominated by the Syndicate shall be two years.

**4. The Committee shall have the power to invite and consult persons having expert knowledge and experience in establishing world class library with regard to the establishment of the KSLU library.**

### **5. Meetings of the Committee:**


The Committee shall meet ordinarily once in 3 months and at other times when conveyed by the Chairman or in his absence by the senior most member on the Board.


## 6. Powers and Functions


- (i) In particular, and without prejudice to the generality of the foregoing powers, the Committee shall have the power to make recommendations to the Syndicate for:
  - a) The allotment of the funds set apart for the Library.
  - b) All the matters connected with the Library.
- (ii) The Committee shall report to the Syndicate, for information, regarding the purchase of books and the disposal of such book as in the opinion of the Committee is either worthless, unserviceable or otherwise useless. For the purpose of this ordinance, books shall include manuscripts and periodicals.
- (iii) The Library Committee shall have the power to make rules governing the use of the Library from time to time and to amend such rules, and any changes made there in, shall be reported to the Syndicate.
- (iv) The Committee shall keep an account of all funds provided for the purposes of the Library and has to forward a statement of such accounts to the Registrar, for submission to the Syndicate every three months.
- (v) There shall be a separate account in the Bank under the name of 'Library Account': (Registrar).
- (vi) All bills in respect of books and other materials purchased for the Library shall be verified, checked and signed by the Librarian.
- (vii) All cheques shall be signed by the Finance Officer, after satisfying himself that the amounts entered in them tally with the bills.

## 6. Repeal and Savings Clause:

- (a) Any Statute existing hereinbefore governing the powers and functions of the Library Committee stands repealed.
- (b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid and remain in force notwithstanding anything contained in this Statute.
