STATUTE GOVERNING UNIVERSITY YOUTH FESTIVAL, 2014

In exercise of the powers conferred under section 23 and section 30(i) of the Karnataka State Law University Act, 2009 (Karnataka Act 11 of 2009) the Syndicate of the Karnataka State Law University hereby amend the following statute namely -

1. TITLE AND COMMENCEMENT:

- (1) This Statute may be called as the "KARNATAKA STATE LAW UNIVERSITY YOUTH FESTIVAL STATUTE, 2014".
- (2) It shall come into force from the date of assent of the Chancellor.

2. YOUTH FESTIVAL:

Youth Festival means and includes organizing all or anyone of the events mentioned in the schedule annexed to this statute at zonal and inter zonal level.

Zone means the cluster or group of colleges shown in the Schedule I annexed to this statute.

- (1) The University shall convene zonal/Inter zonal Youth Festival once in a year.
- (2) The University shall decide the number of events that may be slated in the zonal/Inter zonal Youth Festival choosing from Schedule – I.
- (3) The enlisted events shall be conducted subject to the conditions detailed in Schedule –I and II.

3. ORGANIZATION OF YOUTH FESTIVAL:

The University shall extend invitation to the affiliated Law Colleges requesting them to conduct Zonal Youth Festival in each Zone with the financial support. The Colleges interested in conducting Zonal Youth Festival shall send a proposal including the estimated cost with all the details regarding the same. The Zonal Youth Festival shall be conducted with the prior approval of the University, preferably in the month of September.

If the colleges in any of the zone are not willing to conduct the youth festival then the same will be organized by the University. In any event the colleges in any of the zone are not willing to conduct youth festival within the time fixed by the University, then such event shall be organized by the University in a place convenient to the students of that zone.

The University shall conduct Inter-Zonal Youth Festival by inviting such teams which have secured first place in the zonal youth festival. In case of less number of participants, the University may extend invitation to those teams which have secured second place in the respective events in the Zonal Youth Festival.

4. ELIGIBILITY:

 A student, who is enrolled for a degree or a post graduate degree in law is eligible provided his / her admission is duly approved by the University.

- (2) The student who wishes to participate in the University Zonal/Inter-Zonal Youth festival shall not be more than 30 years on the date of his / her participation in zonal / inter zonal youth festival.
- (3) In case of a student migrating from other Universities, his / her migration case will be considered as eligible only after his / her admission in the University is regularized and is admitted as a student to this University.

5. DISCIPLINE:

Contingent Incharge: for the purpose of this statute means designated Director of Students Welfare or any other such officer / officers deputed by the college for Youth Festival events.

- (1) During the participation in the Youth Festival events no participant, accompanists and Contingent Incharge shall
 - (i) Deviate from the conditions detailed in Schedule -- I
 - (ii) Use Recorded music/ audio cassettes during the Folk/ Tribal, and Creative Dance.
 - (iii) Consume alcohol or drugs;
 - (iv) Indulge in eve teasing;
 - (v) Influence the adjudicators;
 - (vi) Behave indecently in the campus and in the venue:
 - (vii) Arrive to the venue beyond the time scheduled;
 - (vii) Use fireworks.
 - (viii) Indulge in any activity that is unlawful or illegal.
- (2) The Zonal / Inter Zonal Youth Festival Committee is empowered to take appropriate action including debarring the participant from participation in the Youth Festival, for violation of any one or all of the provision of Section 5(1) of the statute.
- In declaring the result for any event conducted during the zonal / inter zonal Youth
 Festival, the decision of the Jury Committee constituted by the Festival Committee
 under section 14(1) shall be final.

7. STRENGTH OF CONTINGENT:

- (1) The participants in a confingent shall not exceed twenty
- (2) Accompanists are preferably be the students, who are eligible to get certificate for their participation.
- (3) In the event of non availability of student as accompanists outside students to a maximum of a may be allowed to participate who shall be a part of the contingent of twenty.

8. CONTINGENT IN CHARGE:

Participating College shall send a maximum of two persons as contingent in charge who shall, maintain a liaison with the Festival Committee of the University. A Lady

contingent leader shall be deputed for girl participants. Officials shall be excluded in the contingent of twenty.

9. IDENTITY CARD:

Identity Cards with photographs signed by the Principal of the respective college shall be carried by each participant and they shall produce the same on demand by any authority.

10. COLLEGE FLAGS & TROPHIES:

The contingent leader shall deposit two flags of his/her college with the Festival Committee. Winners and runners up of the previous year shall bring the trophies with them and surrender before the Festival Committee.

11. TRAVELING EXPENSES:

The participants, accompanists, Contingent Incharge are not entitled for TA from the host colleges / University, for Zonal Youth Festival. However for participating in Inter Zonal Youth Festival the University shall bear second class sleeper/Non AC sleeper bus charge.

12. BOARDING AND LODGING:

University / Host College shall provide boarding and lodging facility free of cost to all the participants, accompanists, Contingent Incharge during the zonal as well as inter zonal youth festival period.

13. FESTIVAL COMMITTEE:

- (1) There shall be a Festival Committee to supervise and regulate the overall Youth Festival at zonal level headed by the Principal of a host college and consisting of a representative from the University and senior most Principal of the colleges participating in the zonal festival as members. The Director Students Welfare of the host college shall be the Convener.
- (2) There shall be a Festival Committee to supervise and regulate the overall Youth Festival at inter zonal level headed by the Dean, Registrar (Evaluation) and senior most Principal of the participating college shall be members. The Director Students Welfare of the University shall be the Convener.
