## STATUTE GOVERNING THE POWERS AND FUNCTIONS OF DIRECTOR OF PHYSICAL EDUCATION, 2021

In exercise of the powers conferred under Section 47 read with Sections 46 (3) of the Karnataka State Law University Act, 2009 (Karnataka Act No.11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Statute for providing for the powers and functions of the Director of Physical Education in the University and to provide for the matters connected thereto.

### 1. TITLE AND COMMENCEMENT:

- a) This Statute may be called as “Statute Governing the Powers and Functions of Director of Physical Education”.
- b) It shall come into force from the date of the assent by the Chancellor.

### 2. POWERS AND FUNCTIONS OF DIRECTOR OF PHYSICAL EDUCATION -

- a) He shall be responsible for organizing Physical Education and Sports activities in the University as well as in affiliated Law Colleges of the University and includes selections for the inter-University sports.
- b) He shall prepare the budget for the conduct of various sports activities organized in the University as well as in affiliated Law Colleges of the University. The said budget has to be prepared based on the recommendation of the Sports Advisory Committee and same shall be placed before the Syndicate for the necessary approval.
- c) He shall, with the aid and advice of the Sport Advisory Committee, frame rules concerning the sports schemes and activities of the University as well as in affiliated Law Colleges of the University.
- d) He shall, with the aid and advice of the Sport Advisory Committee, prepare rules relating to the payment of allowances for the participants and officials who participate/assist in organizing the sports activities organized by the University or who represents the University in various sports activities.

Explanation: the term "officials" include Director/Deputy Director/Assistant Director of Physical Education and Sports, Coaches, Managers, Selection Committee Members, Conveners, Sports Advisory Committee Members and supporting staff.

- e) He shall have the powers to constitute selection committees and appoint members to such committees for the purpose of selecting University teams with the prior approval of Syndicate. The Director of Physical Education and Sports of the University shall be the ex-officio chairman of such selection committees.
- f) He shall place all rules and regulations framed by him before the Syndicate for approval. All such rules come into force from the date of approval by the Syndicate.

### 3. SPORTS ADVISORY COMMITTEE -


- a) There shall be a Sports Advisory Committee to guide and advise Director of Physical Education in exercising powers and Functions provided under this statute.
- b) The Sports Advisory Committee shall be responsible to formulate sports policies, frame rules and regulations of Sports activities from time to time subject to the approval of the syndicate
- c) The Sports Advisory Committee consisting Director of Physical Education of affiliated colleges shall be constituted by the University with the approval of the syndicate.
- d) The Vice-Chancellor shall be the Ex-officio Chairman of the Sports Advisory Committee and the Director of Physical Education shall be Member Secretary of the Sports Advisory Committee.
- e) The Director of Physical Education shall convene meeting of Sports Advisory Committee periodically with at least two meetings in a year and at other times when conveyed by the Chairman. The proceedings of the meeting shall be placed before the Syndicate for approval.
- f) The tenure of the members of Sports Advisory Committee shall be two years. The Quorum for an ordinary meeting shall be seven members. Ten days' prior notice with agenda shall be given for every meeting of the Committee.


### 4. REPEAL AND SAVINGS CLAUSE .

- a) Any Statute existing hereinbefore relating to the Powers and function of Director of Physical Education and Sports and matters connected therewith stands repealed.

b) Any action, decision taken or direction given by the University under any Statute in force at any time earlier than this Statute coming into force shall be valid and remain in force not withstanding anything contained in this Statute.







- B. It was resolved to provide the Traveling Allowances (Train sleeper class/Govt. Bus) and existing DA and other allowances together Rs. 500/- per day for University Blues and KSLU's Law School Students.
- C. Coaches, Managers, Physical Education Directors, Selection Committee Members, Convener, Sports Advisory Committee Members, Director Physical Education etc., Traveling Allowances (III A/C Train or A/C Bus) and existing DA, Honorarium and other allowances together Rs. 1000/- per day.
- D. It was resolved to provide the University Blues the existing Match DA per Student @ Rs. 100 per match for Team Events and @ Rs. 200 for Individual events per heats.
- E. It was resolved to provide the University Blues T-shirts, Shorts, Shoes, socks and Track Suit.

- F. It was resolved to appoint 2 selection committee members from KSLU, one from outside, Director Physical Education of KSLU as Chairman of selection committee and Principal of the host college as the convener to constitute KSLU team to participate in Inter University Tournaments.
- G. It was resolved to appoint one Coach and one Manager for coaching camp and both to escort KSLU Team in Inter University Tournaments.
- H. It was resolved that a maximum of 6 students are permitted to attend the University Blue selection trials from each college.
- I. It was resolved not to levy any entry fees for University Blue Selections.
- J. It was resolved that Physical Education Director of the host college will be the manager for the University team.
- K. It was resolved to provide Badminton Courts by KSLU for hosting Inter University Selection trials to the host colleges.
- L. It was resolved that University Blue selections to be hosted by the organizers of Intercollegiate tournaments including Cricket.
- M. It was resolved to provide the Students securing 01<sup>st</sup> to 08<sup>th</sup> Place in All India Inter University Athletic Competition and students secured 01<sup>st</sup> to 04<sup>th</sup> Place in individual events an award of Rs. 1,00,000/- for each Student.

It was resolved that in case some extraordinary students want to participate in the individual events and team events which are not covered in the Para No. 2 (A), a committee of two Sports Advisory Committee Members, Two event specialized expert and Director Physical Education along with the higher authorities will take a decision to send the team.

### **3. POINT SYSTEM:**

It was resolved to continue the existing Point System Rules of the previous year.

- a) First, Second and Third place cash prize winners of each year will not get any cash award for next three years, but rank certificate will be awarded.
- b) The existing Slab points for standard and quality of sports 1000, 900 & 800 points for First, Second & Third places respectively will be continued.
- c) No slab for Fourth to Sixth place.
- d) 20 negative points for the absence of Managers.
- e) 50 negative points for an indiscipline team.
- f) 3 years ban for inclusion of other than registered college students or Indiscipline.
- g) Each team participating in Intercollegiate Meet, Men and Women events will be awarded 25 points each.
- h) Winning Team in Intercollegiate will get 20 points.
- i) Runners up in Intercollegiate will get 15 points.
- j) Third place in Intercollegiate will get 10 points.
- k) Fourth place in Intercollegiate will get 5 points.
- l) Physical Education Director/Manager escorting the team will be awarded 20 points
- m) University Blue per student will get 25 points each.
- n) Hosting the Intercollegiate Meet 25 points for men and 25 points for women.
- o) Hosting the Selection trial will get 25 points each for Men and Women.
- p) Attending the University selection trial will get 10 points per student.
- q) KSLU's Law School, Navanagar, Hubballi is exempted from the cash award.
- r) Trophies & certificates will be issued for First to Sixth Ranks.
- s) To distribute Sports Equipments to the winners/Ranked Colleges in Point system for each academic year by inviting E-Tender by KSLU existing amount per year as shown below.

- d. It was resolved that host College will provide Food & Accommodation to all the participants and managers. The University shall bear these expenses as per norms.
- e. It was resolved that Medals, Trophies and Certificates will be provided by KSLU for Intercollegiate competition.
- f. It was resolved that each college must participate in at least 05 Intercollegiate Tournaments per year.
- g. It was resolved to provide per day boarding and lodging charges per student / manager per day @ Rs. 350 to be paid to the host colleges who conduct Intercollegiate Tournaments.
- h. It was resolved to provide amount of Rs. 25,000/- for other expenditure to Colleges which organize Intercollegiate Competitions for Men and Women Separately.

- i. It was resolved to provide the amount of Rs.1,00,000/- for expenditure to the College which conducts Intercollegiate Cricket Tournament.
- j. It was resolved to give advance amount of Rs. 50,000/- to colleges which organize intercollegiate competitions and Rs. 1,00,000/- for college which conduct Intercollegiate Cricket tournament.
- k. It was resolved that the host College shall arrange a clinic on rules and regulations in their respective Game at the existing honorarium of Rs. 1,000/- to be borne.
- l. It was resolved that Intercollegiate Athletic Meet will be held at KSLU.
