ORDINANCE GOVERNING ISSUANCE OF ELIGIBILITY CERTIFICATE TO THE STUDENTS OF 3 YEAR /5 YEAR LL.B. PROGRAMME AND LL.M. PROGRAMME, 2021

In exercise of powers conferred under Section 30(i) read with Sections 48(1) (a) and (c) of the Karnataka State Law University Act, 2009 (Karnataka Act No:11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Ordinance for providing for the issuance of Eligibility Certificate to the students for securing admission in affiliated law colleges / KSLU's Law School. Hence this Ordinance.

1. Title and Commencement -

- a) The Ordinance may be called as "Ordinance Governing Issuance of Eligibility Certificate to the Students of 3 Year / 5 Year LL.B. Programme and LL.M. Programme, 2021".
- b) It shall come into force from the date of assent of the Chancellor.
- 2. Eligibility Certificate for admitting students to various programmes under Karnataka State Law University.
 - a) The applicant who has passed the prescribed qualifying examination from recognized Board/Universities which are situated outside Karnataka or in a Foreign Country shall compulsorily obtain the Eligibility Certificate before taking the admission.
 - b) Such candidates shall apply for the Eligibility Certificate to the Karnataka State Law University in the prescribed form by paying necessary fees as prescribed by the University. The application shall be accompanied with attested documents of 10th Std., 12th Std., and Under Graduate certificates as applicable along with transcripts issued by the Board/Department/University concerned.
 - c) On receipt of the application along with necessary documents, the academic section of the University shall scrutinize the same for verifying whether the application is complete in all respect.

- d) If the application is found to be complete in all respect then same shall be forwarded to the Registrar.
- e) The Registrar, after satisfying himself that the application is complete in all respect, shall proceed to issue Eligibility Certificate, that too, after obtaining the approval of Hon'ble Vice-Chancellor.
- f) In case, the application is found to be incomplete in any respect including nonpayment of prescribed fees, then the Registrar may direct the student concerned to submit the required information or pay prescribed fees within a prescribed date.
- g) If the student so directed fails to submit the required information or pay prescribed fees within prescribed date, then the Registrar may reject the Eligibility Certificate.
- h) If any dispute arises with regard to the approval or rejection of Eligibility Certificate, the same shall be referred to the Hon'ble Vice-Chancellor.
- i) The decision of the Hon'ble Vice-Chancellor in this regard shall be final and binding.
- j) Fees for Eligibility Certificate shall be Rs.3000/-(Rupees Three thousand only) for Indian students and Rs.15,000/- (Rupees Fifteen thousand only) for Foreign students and same shall be paid through online payment or as stipulated by the University from time to time.
- k) Fees for Eligibility Certificate may be enhanced by the University from time to time.
- I) The Principal of affiliated law college / Director of Law School shall admit the students to whom the Eligibility certificate is issued to the particular programme.
- m) If any Affiliated Law College admits a student, who has studied outside Karnataka or under Foreign Board/University, without Eligibility Certificate, then the Registrar shall have the power of issuing order for cancelation of such admission.

3. Repeal and Savings-

a) Any Ordinance existing hereinbefore relating to issuance of Eligibility Certificate to the Students of 3 Year / 5 Year LL.B. Programme and LL.M. Programme stands repealed. b) Any Action, decision or direction taken or directed by the University under any Ordinance in force at any time earlier than this Ordinance coming into force shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Ordinance.
