ORDINANCE GOVERNING MIGRATION/MIGRATION CERTIFICATE OF THE STUDENTS, 2021

In exercise of powers conferred under Section 30(i) read with section 48 (1)(a) and (c) of the Karnataka State Law University Act, 2009 (Karnataka Act No:11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Ordinance for providing for the Migration of students from the Karnataka State Law University to other Universities. Hence this Ordinance.

1. Title and Commencement: -

- a) The Ordinance may be called as “Ordinance Governing Migration/ Migration Certificate of the Students, 2021.”
- b) It shall come into force from the date of assent of the Chancellor.

2. Migration of students from Karnataka State Law University to other Universities: -

- a) Migration of Students from Karnataka State Law University to other Universities may be allowed under the following conditions: -
 - (i) Student must have taken admission in any of the law colleges affiliated to the Karnataka State Law University and his/her admission must have been approved by the Karnataka State Law University.
 - (ii) The Migration is permitted only if, the student has completed/discontinued the course to which he/she has been admitted.
 - (iii) The student, who is interested in seeking transfer from one University to other universities, shall apply to the University through the Principal along with the prescribed fees and necessary documents.
 - (iv) Student shall submit an application for Migration in the prescribed form along with the necessary enclosures to the College. The Principal/Director of the college shall verify the particulars in the application and record the certificate in the prescribed form and issue No Due Certificate and forward the application along with necessary enclosures to the University.
 - (v) The Principal of the admitted Law college shall verify the documents as specified below:
 - a. The duly completed application form for Migration;

- b. All/Last Semester Marks Card;
 - c. No Due Certificate;
 - d. Proof of fees, as prescribed by the University from time to time, paid to University;
- b) On receipt of the application for Migration, the Deputy Registrar has to scrutiny the application to verify whether application is complete in all respect and is in accordance with the requirements of the Ordinance.
 - c) After scrutiny, the Deputy Registrar has to forward such applications which are complete in all respect to the Registrar.
 - d) The Registrar, after satisfying himself that applications so forwarded are complete in all respect, may proceed to issue the Migration certificate, that too, after obtaining the approval of honorable Vice Chancellor.

3. REPEAL AND SAVINGS

- a) Any Ordinance existing hereinbefore relating to migration of students from Karnataka State Law University to other Universities stands repealed.
- b) Any Action, decision or direction taken or directed by the University under any Ordinance in force at any time earlier than this Ordinance coming in to force shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Ordinance.
