This made me design a table which consisted of:

- b) A white board attached to the table, allowing students to replicate the traditional classroom experience by visually presenting their ideas and explanations.
- c) Adjustable and flexible mobile holder used for:

Once I made this product and started using it, I realized that I could market the same product as it was the need of the hour. I shot a small advertisement video and shared it with my faculties and my college-mates.


Everyone was so impressed by the product that they started placing orders.


Faculties helped me a lot in promoting the product through their good network links. I must say that they helped me bag a good number of orders.

# 2) PRODUCTION OF ECO-FRIENDLY PENS

My second venture began with production of eco-friendly pens, when I was in my 4<sup>th</sup> year of B.B.A.,LL.B.(HONS).

We still were having lockdown and online classes. I started reading about plastic pollution and sustainability.

When I researched about plastic ball pens and their recycling, I was shocked to see that tons of plastic pens every year end up in landfills. There is little to no recycling of used plastic pens.

So I started searching for an alternative that is ecofriendly. I stumbled upon paper pens, but these pens were very expensive...

Thus, I started preparing the prototypes of paper-pens which were not expensive to make and were eco-friendly (since most of the material used is paper except for refill), which can tackle the menace of plastic pollution.

Thus, I prepared a product (eco-friendly pens) which was:

- a) A paper ball pen (made from recycled paper and newspapers)
- **b)** A pen whose 90% part is Biodegradable (as most of its part is made up of paper which is biodegradable)
- c) Cheap price/ Cost effective (was able to make/ produce the product which costs nearly as much as its plastic counterpart)
- d) Highly customizable.

I shot an advertisement for the product and floated the same on WhatsApp, You Tube, etc.

My friends and teachers were very supportive in promoting and trying out my new product.

Thus,I started getting orders. It also caught the attention of people running various tuition classes who ordered bulk of these pens for promotional activities, birthday orders etc.




